Summary of Events

On 27 and 28 October 1999, the Federation Commission on Missing Persons – Bosniak Side conducted recovery operations at four sites in the general vicinity of Kotor Varoš. No remains were recovered from a cemetery site in Vrbanjci, but remains of 14 individuals were exhumed from the other sites.

Background information on these recovered individuals was not available at the time of report writing.

A Physicians for Human Rights (PHR) Forensic Consultant was present for the recovery operations.

Remains were transported to autopsy facilities in the Federation of Bosnia and Herzegovina. Postmortem examination results had not been forwarded to PHR at the time of writing.

Narrative




Figure 1. (1) Vrbanjci (2) Hrvacani




Figure 2. (3) Kukavice (4) Zagrade

The sites are in the general vicinity of Kotor Varoš (Figure 1: Topographic Map Maslovare; Sheet 2684 III; Edition 6-DMA; Series M709; Scale 1:50,000; and Figure 2: Kotor Varoš; Sheet 2584 II; Edition 6-DMA; Series M709; Scale 1:50,000). Grid coordinates for all sites were determined using a Global Positioning System (GPS) unit (see Table 1).

Details of operations at these sites were not available at the time of report publication.

Postmortem Examination Findings

Postmortem examination results had not been forwarded to PHR at the time of report writing. Results will be filed with this report once received.
