## **Executive Summary**

This final report presents the results of the archaeological resolution works carried out on behalf of Kildare County Council and the National Roads Authority as part of the Archaeological Services Contract No. 5 - Resolution, Kilcullen to Moone and Athy Link Road. The works were undertaken prior to the commencement of construction of the N9/N10 Kilcullen to Waterford Scheme: Phase 3, Kilcullen to Carlow. The Minister of the Environment, Heritage & Local Government, following consultation with the National Museum of Ireland, issued Directions to Kildare County Council on 8 March 2007 for archaeological resolution works relating to the road development. The registration number, E2877, was allocated by the Department for the excavation of the present site in Ballymount townland under the directorship of Gillian Mc Carthy of Headland Archaeology (Ireland) Ltd.

An Environmental Impact Assessment was published in 2003 for the Kilcullen to Powerstown Scheme, with Valerie J Keeley Ltd preparing the Archaeological, Architectural and Cultural Heritage Assessment. This formed Chapter 10 of the EIS produced by the Roughan and O'Donovan - Faber Maunsell Alliance. Geophysical prospection was carried out on certain areas of high archaeological potential by Bartlett-Clark Consultancy as part of the Environmental Impact Assessment, on behalf of Valerie J. Keeley Ltd/Kildare County Council.

Aerial photography was undertaken along the entire route selection as part of the non-invasive assessment after the EIA stage. This work was carried out in April 2004 by Markus Casey.

Archaeological testing carried out by IAC Ltd under N9/N10 Kilcullen to Waterford Scheme: Kilcullen to Powerstown. Archaeological Services Contract No. 1 – Test Excavations, Kilcullen to Mullamast under Ministerial Direction Number A021/090 on this site between 8 May and 28 August 2006 identified a linear feature which was aligned northwest/southeast and was cut by a furrow. It was 7.5 m in length was 2.1 m in width and had a depth of 0.7 m. The primary fill was mid-brown loose silty clay which had a depth of 0.6 m. The lower fill was yellowish brown compact silty clay which had frequent inclusions of small sub angular stones and was 0.1 m in depth.

Full archaeological resolution was conducted on this site between 1 October 2007 and 16 October 2007. This revealed a post-medieval double linear field boundary cut by a furrow with parallel furrows to the north. A Preliminary Report of works on the site was completed by Headland Archaeology (Ireland) Ltd in February 2009.

## 1 Introduction

The N9/N10 Kilcullen to Waterford Road Scheme, of which the Kilcullen to Powerstown Scheme forms part, was proposed as a High Quality Dual Carriageway/Motorway, forming the Major Inter Urban route between Dublin and Waterford. The Kilcullen to Powerstown Scheme was advanced as a single entity up to the Compulsory Purchase Order/Environmental Impact Statement and was subsequently divided into two separate construction contracts: the Carlow By-pass (Phase 1) and the Kilcullen to Carlow Scheme (Phase 3). Kildare County Council, National Roads Design Office, has responsibility for overseeing the project management of these two schemes. The entire road scheme from Kilcullen to Waterford has now been designated as Motorway.

An Environmental Impact Assessment was published in 2003 for the Kilcullen to Powerstown Scheme, with Valerie J Keeley Ltd preparing the Archaeological, Architectural and Cultural Heritage Assessment. This formed Chapter 10 of the EIS produced by the Roughan and O'Donovan - Faber Maunsell Alliance. Geophysical prospection was carried out on certain areas of high archaeological potential by Bartlett-Clark Consultancy as part of the Environmental Impact Assessment, on behalf of Valerie J. Keeley Ltd/Kildare County Council.

Aerial photography was undertaken along the entire route selection as part of the non-invasive assessment after the EIA stage. This work was carried out in April 2004 by Markus Casey.

Construction commenced on Phase 1, the Carlow By-pass, in January 2006 and the road was completed and opened in May 2008. Construction of Phase 3, the Kilcullen to Carlow Scheme, which also includes a new single carriage link road to Athy town, commenced in January 2008.

Archaeological test-trenching was undertaken in advance of Phase 1, the Carlow By-pass, by Headland Archaeology (Ireland) Ltd between June and August 2005 (Archaeological Services Contract No. 3). This work identified 64 archaeological sites, which required archaeological excavation in advance of road construction. The resolution works for these sites were undertaken by Headland Archaeology (Ireland) Ltd between January and August 2006 (Archaeological Services Contract No. 4).

Archaeological test-trenching was undertaken in advance of the construction of Phase 3, the Kilcullen to Carlow Scheme, by IAC Ltd and CRDS Ltd, between October to November 2005 and May to August 2006 (Archaeological Services Contracts No. 1 and No. 2, respectively). This work resulted in the identification of 102 archaeological sites, which required resolution in advance of construction. The resolution works for these sites were undertaken by Headland Archaeology (Ireland) Ltd between March and December 2007 (Archaeological Services Contracts No. 5 and No. 6). This report details the results of one of those excavations, undertaken under NMSR Number E2877.

The project was funded by the Irish Government and the European Union through Kildare County Council/National Roads Authority, under the National Development Plan 2000-2006 and 2007-2013.

Construction Phases 2 and 4 relate to the section of road between Powerstown, Co. Carlow and the Waterford city By-pass and are project managed by Waterford County Council, National Roads Design Office.

## 2 Site description and location

Site E2877 was situated in the townland of Ballymount, parish of Usk, barony of Narragh and Reban East, and was located 8.1 km south of Kilcullen, Co. Kildare at National Grid Reference: 282180/201780 (Figure 1). The site was located on a gravel ridge at the southeastern edge of Narraghmore bog, west of the current N9.

One RMP is recorded within the townland of Ballymount. An enclosure (RMP KD032-052) is located 350 m southeast of the site. Other known archaeological sites in the vicinity of E2877 include a ringfort (RMP KD032-032) 1.2 km to the south, and an enclosure (RMP KD032-026001) and stone circle (RMP KD032-026002) 1.3 km to the east. The stone circle is referred to as 'The Piper's Stones' on the 1st edition OS 25" map.

Archaeological investigations undertaken as part of Archaeological Services Contract No. 5 on the road scheme identified a number of nearby Bronze Age burnt mounds and associated features at; Ballymount, E2874, 800 m to the south (Hanbidge 2010); Ballymount, E2873, 900 m south (Hanbidge 2009b); Ballymount, E2872, 1 km south (Twomey 2009); and Blackrath, E2871, 1.1 km north, (Hanbidge 2009a). An early Bronze Age settlement was excavated at Baronsland E2878, 1.9 km to the north (O'Malley *et al* 2009), and an early medieval cereal-drying kiln, and a series of pot-medieval agricultural features were uncovered at two further sites in Baronsland, E2880 (O'Malley *et al* 2009b) and E2881 (O'Malley 2009). Also in Ballymount at E2875 was a cluster of pits postholes and stakeholes (Frykler 2009), while two Late Bronze Age cremations and three adjacent pits were excavated 1.75 km south at Blackrath, E2870 (Twomey 2009)

## 3 Aims and methodology

The objective of the work was the preservation by record of any archaeological features that would be impacted by the proposed development, in advance of the road construction programme.

Topsoil stripping of the site was conducted using a 360° tracked machine fitted with a 1.9 m wide ditching (toothless) bucket under constant archaeological supervision. A total area of 900 m<sup>2</sup> was exposed. The resulting surface was cleaned and all potential features investigated by hand. Archaeological contexts were recorded by photograph and on *pro forma* record sheets. Plans and sections were drawn at scales of 1:20 and 1:10 respectively. Registers are provided in the appendices (Appendices 1-5). Ordnance Datum levels and feature locations were recorded using Penmap and a total station theodolite.

Environmental samples, including animal bone samples, were taken of any deposits suitable for analysis or dating as per Headland Archaeology (Ireland) Ltd environmental guidelines and following consultation with environmental archaeologist and archaeobotanist Karen Stewart and zooarchaeologist Dr. Auli Tourunen. Artefacts recovered during the excavation were assigned unique numbers and treated in accordance with National Museum of Ireland guidelines.

Full archaeological resolution was conducted on this site between 1 October and 16 October 2007. The crew on site E2877 consisted of 1 director, 1 supervisor and 3 site assistants.

Given the absence of archaeological artefacts and worked/charred wood no specialist reports were produced in relation to this site.

#### 4 Excavation results

Following topsoil removal, two parallel linear ditches (003) and (010) were uncovered running in a west-northwest/east-southeast direction across the site with a distance of 3.5 m between them (Figure 3). A number of furrows were also discovered running over these linear ditches.

##### *Ditches*

Linear ditch (003) (Plate 1, Figure 3) measured 1.4 m in width, 0.7 m in depth and extended beyond the CPO at its east-southeastern end and had a west-northwest/east-southeast orientation. It had sharp breaks of slope on top, gradually sloping sides, and a concave base with gradual breaks of slope. It contained a basal fill (020) which consisted of mid-brownish grey loose silty sand with charcoal inclusions and small animal bone fragments (E2877:001), and had a depth of 0.35 m. Overlying context (020) was deposit (019) which filled the majority of the ditch. It measured 1.4 m in width and 0.3 m in depth and was dark greyish brown loose silty sand with a horizontal lens of charcoal which ran through the fill. The upper fill of the ditch (004) consisted of silty sand with only occasional charcoal inclusions and had a depth of 0.20 m. Two pieces of post-medieval, probably 20<sup>th</sup> century pottery were found in this fill (E2877:004:001) and (E2877:004:002). To the southern side of this ditch was a later recut (021). It ran directly along the southern side of the ditch (003), measuring 0.75 m in width, 0.3 m in depth and also extended beyond the CPO at its east-southeastern end. This contained a single fill (022), mid-brownish grey hard clayey sand. This was probably a drainage ditch or an attempt to re-establish linear ditch (003).

Situated 5 m to the north of linear ditch (003), and running roughly parallel to it, was a linear ditch (010) (Plate 2, Figure 3). This extended beyond the CPO at its east-southeastern end and had a west-northwestern/east-southeastern orientation and measured 1.6 m in width and 0.63 m in depth. It had gradual breaks of slope, gradually sloping sides and a rounded base. The basal fill (018) was mid-greyish brown hard sandy clay with occasional small stone inclusions. It measured 1.3 m in width and 0.4 m in depth and ran the entire length of the ditch (010). Overlying fill (018) was fill (011) which measured 1.55 m in width and 0.2 m in depth. It was mid-brownish grey hard clayey sand with occasional small stone inclusions. It also contained a post-medieval iron hook (E2877:011:001) and animal bone (E2877:002). This ditch was cut into the natural but at the east-southeastern end it was cut into a subsoil layer (009), which was a loosely compacted mid brown clayey sand with occasional inclusions of small stones, measuring 1.45 m in width and 0.13 m in depth.

##### *Furrows*

Five west-northwest to southeast orientated furrows where also identified running parallel to each other at a distance of 1.3 m apart (Figure 3). All had concave sides and flat bases. Furrow (005) cut across the ditch (003) and also the ditch (010). It measured 0.66 m in width and 0.12 m in depth and contained the fill (006) which was light greyish brown soft clayey sand.

Furrow (007)/(025) ran parallel to (005) (Plate 4) at a distance of 2.5 m. It measured 0.65 m in width and 0.25 m in depth. It contained the fill (008)/(026) which was mid-greyish brown soft clayey sand which contained some small stone inclusions. Furrow (007)/(025) cut a possible earlier drain/furrow (016); it measured 0.17 m in depth, 0.3 m in width and contained the fill (017) which consisted of mid-brownish grey compact silty sand. It was only visible for 1 m and may only have been a drainage feature. Furrow (012) ran parallel to furrow (007)/(025) at a distance of 2.5 m to the northeast. Furrow (012) (Plate 3) measured 0.85 m in width, 0.16 m in depth and contained the fill (013) which consisted of light orangey brown hard clayey sand. Furrow (014) ran parallel to the furrow (012) at a distance of 2.5 m to the northeast. Furrow (012) cut linear ditch (010). Furrow (014) measured 0.83 m in width and 0.13 m in depth and contained the fill (015) which consisted of light orangey brown hard clayey sand. Furrow (023) ran parallel to the furrow (014) at a distance of 2.5 m to the northeast. The furrow (023)

measured 0.6 m in width and 0.1 m in depth and contained the fill (024) which consisted of mid-greyish brown loose clayey sand.

## 5 Discussion

The results of the excavation at Ballymount are discussed here following stratigraphic, environmental, dating and artefactual analysis. The site is then discussed on a local level and related to other sites known in the vicinity (including those discovered on the current scheme). The site will also be discussed on a national level in an attempt to place it in context and assess how it contributes to the archaeological record in general.

Artefacts uncovered from the upper fills of ditches (003) and (010) suggest both were open in the post-medieval period (Appendix 2). Ditch (003) is represented as an upstanding field boundary on the 1st Edition 6" OS map of 1839. It is no longer extant however, in the third edition OS map of 1907/09, it reflects field consolidation in this area in the late 19<sup>th</sup>/early 20<sup>th</sup> centuries. Linear ditch (010) could have been a bank with a ditch to either side, hence both ditches could represent the same boundary

The features recorded on site E2877 reflect the history of agricultural land use in the area from post-medieval times through to the modern day. The site provided evidence for landscape change and maintenance through the construction and subsequent removal of field boundaries, and ploughing;. Adjacent sites have revealed evidence for intense prehistoric occupation across this area. However they also have also provided us with the remains of its post-medieval archaeology with features of a similar nature to those excavated on site E2877. A removed field boundary was excavated on sites E2874 (Hanbidge 2010), E2873 (Hanbidge 2009b) and E2872 (Twomey 2009a) approximately 0.80 km, 0.90 km and 1.10 km respectively southwest of E2877, while a similar arrangement of two parallel ditches, one of which was represented on the First Edition Map, was uncovered on site E2876 (Twomey 2009b) 0.25 km to the southwest and site E2881 (O'Malley 2009) 2.30 km to the northeast.

The five furrows uncovered all post-date these ditches. The shallow nature of the features and the uniformity of their shape and orientation reinforces the validity of their interpretation as furrows.

The evidence from the other sites in its vicinity support the notion that site E2877 should not be viewed in isolation but rather as part of a greater post-medieval agricultural landscape.

All the archaeology related to this site within the CPO has been resolved.




Figure 1 - N9/N10 Kilcullen to Waterford Scheme: Phase 3, Kilcullen to Carlow. Archaeological Services Contract No. 5 – Resolution, Kilcullen to Moone and Athy Link Road: E2877 site location.




Figure 2 - N9/N10 Kilcullen to Waterford Scheme: Phase 3, Kilcullen to Carlow. Archaeological Services Contract No. 5 – Resolution, Kilcullen to Moone and Athy Link Road: E2877 extract from RMP.




Figure 3 - N9/N10 Kilcullen to Waterford Scheme: Phase 3, Kilcullen to Carlow.
