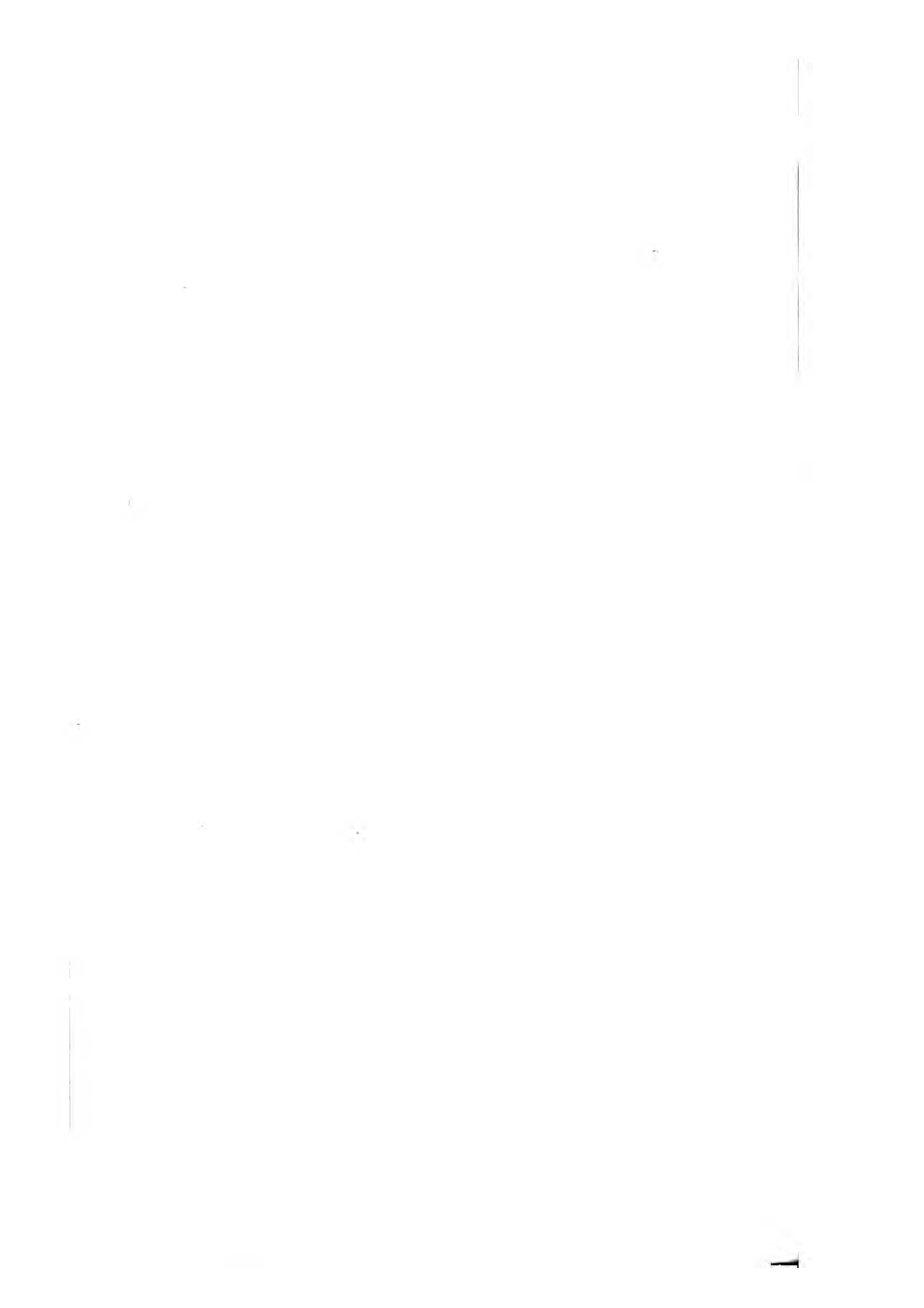

P R E F A C E



THE object of this book is to set forth the relative positions of the Learned and Unlearned in the study of Holy Scripture,—meaning by the unlearned that great class of students who, however intelligent, do not possess the advantage of personal acquaintance with the languages in which the Scripture was originally written, or who, even if they have acquired some acquaintance with these languages, are not competent to form a judgement on questions which depend exclusively or mainly on the niceties of pure scholarship. The rights and legitimate functions of this class, which with scant propriety we call the unlearned, need to be safeguarded. There is a disposition in many quarters to recognize a class of specialists among Bible students, analogous to the class of acknowledged specialists in the departments of theoretic and practical science, and even to allow them a more exclusive authority than is often allowed to these. Questions which are agitating

the public mind to its very depth, and which involve the most serious issues, in relation to the integrity and trustworthiness of what we have been accustomed to regard as the Word of God, and in relation to the highest spiritual interests, are declared to be 'emphatically not people's questions.' 'The solution of these difficulties, if they are ever to be solved,' we are told, 'can only be the work of men who are equipped for the service with special philological and historical knowledge and acumen.' And at the feet of those who are so equipped, they who are not are bidden to sit as humble learners till the solution is published with authority.

In the following pages the writer endeavours to separate truth from untruth in this matter, and to maintain the legitimate rights of those who may be called non-experts; and having done so, he sets forth certain reasons which justify these non-experts in holding by the main positions of the older criticism of the Old Testament scriptures, and rejecting the main positions of the newer,—reasons which are in no respect inconsistent with the highest scholarship, and whose soundness no scholarship can neutralize or render doubtful.

PART FIRST

THE PLEA STATED, ARGUED, AND ILLUSTRATED

THERE are departments of knowledge in reference to which the great bulk of even well-educated men must be content to accept conclusions on the authority of others. Astronomy may be named as an example. The observations and calculations of astronomers belong to a region which is as a *terra incognita* to the mass of mankind. But the soundness of the Copernican theory of the solar system, which underlies them, and of the laws of gravitation which are associated with the names of Newton, Halley, and Kepler, and which are the bases of astronomical calculations, is proved to the perfect conviction of all men by results, the truth and accuracy of which need no demonstration but that of the naked eye. The most

popular and least scientific calendars which we can purchase for a few pence at the beginning of any year, tell us, for example, what eclipses of the sun and moon will take place during the year, the extent of the eclipse, the moment of its commencement, the moment of its ending; and the parts of our earth's surface where the eclipse will be seen. The astronomical prediction never fails of accomplishment; and the authors of it may be called Experts, as distinguished from those who cannot follow their processes and must content themselves with results.

It scarcely needs remark, and yet the remark must be made, and we shall soon find it of importance, that there is no true analogy between such experts and those who call themselves, or rather who are called, experts in biblical or literary criticism. There are two departments, it is true, which those who are not versed in the original languages of Holy Scripture must relegate to those who are. These are textual criticism and translation. The very first concern of the late revisers of our English Bible was to settle the *Texts*¹ which they were to translate; and in their prefaces they have explained the principles on which they proceeded. The Old Testament revisers tell us that their difficulties in this matter were greater than those of the New Testament revisers, and they thought

it 'most prudent (they say) to adopt the Massoretic (the Received) Text, as the basis of their work.' So far as known MSS. of the Old Testament are concerned, it seems to be admitted that there is little prospect of much further light being thrown on the subject. Hopes are entertained, however, though not with much confidence, that a more thorough study of the ancient versions—the Greek, Syriac, Coptic, Armenian, and Latin—may result in some improvement of the Text. As to the New Testament, the means of attaining certainty are much greater than in the case of the Old. And 'a revision of the Greek Text was the necessary foundation of the work' of the revisers; but they say 'it did not fall within their province to construct a continuous and complete Greek Text.' The main principles by which they were guided are fully explained in their preface.

This is a matter which the unlearned, the non-Hebraists and non-Grecians, must leave in other hands than their own. But in doing so they do not suffer any material disadvantage in their endeavour to understand Holy Scripture. Consider these points:

1. The number of Hebrew scholars who are capable and have the opportunity of original textual investigation is after all comparatively small.

2. The subject of their special study does not admit of the possibility of a unanimous consensus, as in a matter of science, even on the part of the most select and most skilful of textual critics.

3. The results of textual criticism, whatever they may be, and with whatever doubt or confidence they may be asserted, are not hidden from the uninitiated, but soon become the possession of the world at large. To these considerations another has to be added, the force of which will be recognized at once, namely ;

4. That the accumulated experiences of the past in this department confirm our confidence in the substantial trustworthiness of the texts which are represented in our English translation, and leave no room for the expectation that the future will produce any material change. Christians are sometimes alarmed by being told of an enormous number of 'various readings' in Greek manuscripts of the New Testament. But it is a false alarm, as any one may discover for himself if he will only observe the few, and, with scarcely an exception, trifling, changes which the revisers have found necessary.

A learned commentator on Homer, discussing the 'various readings' in the great Greek epic, the *Iliad*, illustrates his subject by an incidental reference to the various readings of the Greek New Testament. 'For the most part (he says) a mere variety in the position of the words, or in the method of spelling, in the presence or omission of the article, or a change in some insignificant epithet, is all the fruit that weeks and months consumed in the laborious work of comparing old manuscripts can boast of; and when we find a learned man like Wetstein devoting his whole life to the comparison of such insignificant

variations of the Greek Text as our New Testament exhibits, we are inclined almost to withhold our pity from him, when we find him complaining that, after long years spent in adjusting the sacred text, he had got as his reward only "weak eyes and a disqualification for every other pursuit."'

It is not to be inferred, however, that the labours of textual critics are wasted. Far from it. Every correction, the smallest, which is effected by them, is worth the pains which have produced it. And, above all, 'The negative results are of the utmost consequence. The Christian world knows, with a confidence which were otherwise impossible, that the book which contains the charter of its inheritance has lived through centuries, undamaged in all essentials, whether from the blundering of ignorant copyists, or the falsification of unscrupulous partisans¹.'

It will thus be seen that the unlearned share the fruits of learning, and are not practically damaged by their dependence on others in the department of textual criticism.

The same line of argument may be followed with reference to their dependence on others for the translation of Holy Scripture, and it need not be repeated. Those who can read the Hebrew and Greek originals for themselves have a certain advantage over others, in that the original often produces a more vivid and more suggestive impression than the familiar English produces. But unless

Hebrew and Greek had become universal languages, the greater part of mankind must of necessity depend on translations. And it is an instructive fact that the Jews, the Hebrews themselves, in the time of Christ, especially those of the Dispersion, were more familiar with a translation, than with the originals which had come down to them in the tongue of their fathers. These originals were very sacred, and held a place to which no translation could aspire. But the Greek Septuagint was in general use, and though it was not inspired, and was far from being a correct translation, apostles did not hesitate to quote it, as we quote our English, as the word of God.

This is a fact of no mean importance. It does not diminish the reverence that is due to the words that were written by prophets and apostles, and which must ever be regarded as the final court of appeal, but it justifies the right of translation, and proves the possibility of conveying, truly and sufficiently, the Divine meaning of the originals to those to whom the originals are a sealed book. The memorable doctrine which Christ announced to the woman of Samaria has a bearing on languages as well as on places. They that worship the Father in spirit and in truth are not dependent on the tongues of Jerusalem and Gerizim for their knowledge of Him or for their power of worship. The apostles on the day of Pentecost knew that the good news which they were inspired to proclaim was as true and Divine in all the

languages that were native to the devout men from every nation under heaven, as it was to the home-born men of Jerusalem who had heard the voice of Christ Himself. On the basis of this fact Bible Societies rest. The day of Pentecost is their model, and by means of the printing-press they essay to do for all nations and for all ages, what the apostles did on that day for the multitude around them. Their work will be completed only when the joyous echo comes from the whole wide world, 'We do read, every man in his own tongue, the wonderful works of God.'

We now turn to the Book itself, to ascertain whether it indicates any incapacity on the part of those who receive it to understand it, or any indication of an authority standing between them and the Book, to prescribe the sense in which its words are to be understood. Here the way is clear before us. Moses spoke with authority, but he interposed no authority between himself and the people. There needed none. 'This commandment which I command thee this day, it is not hidden from thee [R.V. it is not too hard for thee], neither is it far off. It is not in heaven, that thou shouldest say, Who shall go up for us to heaven, and bring it unto us, that we may hear it, and do it? Neither is it beyond the sea, that thou shouldest say, Who shall go over the sea for us, and bring it unto us, that we may hear it, and do it? But the word is very nigh unto thee, in thy mouth, and in

thy heart, that thou mayest do it ' (Deut. xxx. 11-14). These words were not addressed to a select class, but to the assembled nation. The statutes and judgements with reference to which Moses said, ' I call heaven and earth to record this day, that I have set before you life and death ' (ver. 19), were to be ' taught diligently ' even to children (Deut. vi. 4-9). At the end of every seven years, ' in the solemn year of release,' it was ordained that the law should be publicly read before ' all Israel.' ' Gather the people together (the Lawgiver said), men, and women, and children, and thy stranger that is within thy gates, that they may hear, and that they may learn, and fear the Lord your God, and observe to do all the words of this law ! ' (Deut. xxxi. 10-12). The priests and the elders of the people were charged with the fulfilment of this ordinance, but were invested with no authority besides. When Ezra read ' the book of the law of Moses, which the Lord had commanded to Israel,' to the ' men and women ' who had returned from exile, we are told that ' they gave the sense, and caused the people to understand the reading ' (Neh. viii. 1, 8). This probably means that they translated the Hebrew of Moses into the Aramaic dialect which the people now spoke. It may mean likewise that Ezra and the priests who aided him in this memorable work, expounded to the people as they read the requirements of the law with its promises and threatenings. But exposition implied no authority then any more than it does now.

What is true of the teaching of Moses is true of the teaching of prophets. They too spoke with Divine authority ; but between their words and the people there stood no one to tell the people how they must understand them. 'Write the vision (the Lord said to Habakkuk), and make it plain upon tables, that he may run that readeth it' (ii. 2). When the vision became at any time as 'the words of a book that was sealed,' it was not that they were hard to understand, but because the people would have it so (Isa. xxix. 9-16).

Reference may be made in this connexion, though it is scarcely necessary, to the Jewish fable of an oral law by which the written law was to be interpreted. The Talmud says that during the whole day while Moses continued on the mount, he was learning the written law, but at night he was occupied in receiving another law explanatory of the first, which he was commanded not to commit to writing, but to hand down by oral tradition. When Jerusalem was taken by the Romans, and the temple destroyed, and the nation scattered abroad, it was feared, we are told, that the traditional law might be lost, and therefore it was resolved to preserve it by committing it to writing. This was done by 'Judah the holy,' about the middle of the second century of our era. Hence the Talmud.

Over against this story we need only recite the words of the history of the law-giving : 'Moses came

and told the people *all* the words of the Lord ; . . . and Moses *wrote* all the words of the Lord ' (Exod. xxiv. 3, 4). Throughout the entire history of the nation from that time onward to the latest of the prophets, we search in vain for a single phrase or allusion that might indicate the existence of any other than the written law. And when in the Gospels we find references to traditions of the fathers, we still find no appeal to an oral law contemporaneous with the written. The traditions were only the comments of Rabbinical teachers, and their general effect was to make void the one Law which alone bore the seal of God.

If we turn to the New Testament we still look in vain for the existence of an authority, outside its own pages, to determine for the reader how he should understand the apostolic words. The matter may be tested by a reference to the Epistles of St. Paul. This great apostle possessed and claimed the authority of Christ for his teaching. He knew 'the mind of Christ.' A dispensation of the gospel was committed to him (1 Cor. ix. 17). By revelation there was made known to him the mystery of Christ (Eph. iii. 2-7). What he preached and what he wrote bore the seal of the Lord whose ambassador he was. But between Paul and his hearer or reader there stood no authoritative interpreter. To the Corinthian Church, the fellow Christians of 'all that called upon the name of Jesus Christ our Lord in

every place' (1 Cor. i. 2), he said, 'Judge ye (ye who read my words) what I say' (x. 15).

The Epistle to the Romans is often described as the most *theological* of all the apostle's writings, and it may be assumed that it was to 'some things' in this Epistle that his fellow apostle Peter referred, when he spoke of 'some things hard to be understood, which the ignorant and unsteadfast wrest, as they do also the other scriptures, unto their own destruction' (2 Pet. iii. 16, R.V.). But neither apostle prescribed, nor suggested the existence of, any intermediary to save even the ignorant and unsteadfast from wresting the Scriptures; an intermediary who should impair the right or diminish the responsibility of those whom they addressed. The readers of the apostolic epistles were, many of them, Jews who carried into the Christian Church prejudices which were to them as a second nature; and many of them heathens who found it equally hard to rid themselves of old superstitions and habits. But the apostles treated them all as capable of understanding their reasons against a Judaic ritualism, as in the Epistle to the Galatians; and against heathen corruptions and heathen philosophies as in the Epistles to the Corinthians and to the Colossians; and they held their readers personally responsible for the right understanding of their instructions.

Christian readers of to-day are not less capable than were those of the first century to understand the apostolic writings; nor are they less responsible

personally for the understanding and practice of the will of Christ, as authoritatively declared by His immediately commissioned ambassadors.

The rejection of the claim of any body calling itself 'The Church,' or of councils presuming to speak in the name of the Church, to come between us and the written inspired word with an authoritative declaration of the meaning of the word, is not to be construed as a rejection of the *aids* which we may derive from the studies of those who have gone before us—the fathers of bygone ages—or our own contemporaries. Such a rejection would be the sign not of a true independence, but of self-willed conceit and arrogance.

If we are right so far, we see (1) that ordinary readers of Holy Scripture enjoy all the benefits of the light which a learning not their own can throw on the original texts of both the Old and the New Testament; and (2) that through translation they enjoy practically all the advantage which those possess who can read the Scriptures in Hebrew or in Greek. We have seen likewise (3) that the books themselves recognize no authority as standing between them and their readers. The attempt to assert such authority issued, in the case of the Old Testament, not in enforcing, but in making void the Divine law. And the case of the New is not very different. If the apostles had risen from the dead four or six centuries after their lifetime—the age to which some would have us bow as authoritative,—their language of

sorrow and amazement would have been, 'We marvel that ye are so far removed from us unto another gospel and other ordinances.'

But may there not have been developed in our times another class of experts, to whose learning and wisdom it will be expedient that we bow? If so, we have to ask who they are and how we shall know them? Are they the men who have attained to a very high knowledge of the language in which prophets spoke and wrote, and of all that can contribute, directly or indirectly, to the understanding of the writings of the Old Testament? Do these constitute a class who are entitled to impose their interpretations on the world? Here we are met at once with an initial difficulty. These very learned men are divided into two irreconcilable and antagonistic forces, on the very questions in regard to which the unlearned are supposed at present to need guidance. The one party find in their learning a confirmation of what is called, though not with strict accuracy, the traditional theory of the Old Testament; the theory which was held — not as a theory, but as an unquestioned fact, through the age of Christ and His apostles until a very recent period—that the five books commonly ascribed to Moses were rightly ascribed to him, and that in these books we have the very foundation of the Jewish polity and of the Jewish history. The other party find in their learning reason to deny

this theory, root and branch, and to maintain that the true beginnings of Judaism and its theology are to be found in the prophets of the eighth century before Christ, and that the histories and laws, with some fragmentary exceptions, which precede these in the book, are due to authors of the prophetic age, and did not attain their present completed form, especially in the matter of law-giving, till after the Babylonian exile. These two classes of the 'learned' are fundamentally contrary the one to the other, and we cannot bow the knee to both.

The idea of authoritative experts based on Hebrew learning is exploded by the fact of this fundamental difference. Neither class has a right to an authority which is not conceded to the other. And perhaps it may be said with truth that neither claims or asserts any such right. But it is claimed or asserted for one of them. It has become a fashion on the part of many to regard the scholars who have adopted the new theories regarding the Old Testament as experts, to the exclusion of scholars who are equally learned ; and it is to them alone we are told to look for a verdict on those problems which are to be taken out of the hands of the people. But why should these be invested with a critical dictatorship?

(1) They do not themselves claim a personal superiority in scholarship over many who differ from them. They may mourn over their learned brethren who ' will not come to the light ' which has shone on their minds, but they do not deny their equal capacity.

(2) Some of the most eminent of them confess that the ultimate decision of great Old Testament problems does not depend after all on scholarship. One of them (Dr. Cheyne) has said emphatically, with reference to a question which he has made very specially his own—that of the second portion of Isaiah—that the decision of the critical question will mainly depend on other than purely linguistic considerations. As to the fifty-third of Isaiah, he says that the question of its true meaning rests less with the critic than with the heart and judgement of the Christian. Dean Farrar, who accepts one of the most painfully destructive, and, as I think, one of the least tenable, conclusions of the Higher Criticism, in the matter of the Book of Daniel, remarks on the uncertainty of the results that are attained on purely philological grounds, and refers to the fact that two Hebraists, so profound as Ewald and Hitzig, take such opposite views of language that the one can feel sure that the second Psalm is of Davidic, and the other of Maccabean origin (*On the Minor Prophets*, p. 104). Kuenen confesses that he has no data for his critical speculations that are not equally possessed by all who have the Bible in their hands. Prof. Robertson Smith is equally explicit. ‘We have (he says) almost no contemporary helps for the study of Hebrew antiquity beyond the books which were received into the Hebrew Canon’ (*The Old Testament in the Jewish Church*, p. 17).

(3) There is a third reason why we should dis-

allow anything like a dictatorship to those who are ordinarily called Higher Critics, and that is the extraordinary differences in the results at which they arrive, while starting from and building on the same critical principles.

As to the old and ever-new question of the right of private judgement in its many bearings—the right of every man to think for himself and to act for himself in his relations to his Maker—enough to say that the denial of the right by man or magistrate, Church or Churchman, throws on the denier the duty of proving his right to deny. And how is that to be proved? Only by proving the possession of authority from Heaven. And the attempt to prove this is itself an appeal to the private judgement of those whom it is designed to convince. It cannot be forgotten that even prophets were not entitled to be heard unless they were in a position to prove their prophetic authority. And Christ Himself did not demand hearing or faith without giving abundant evidence that He had a right to speak in the name of God. If He had not done in Israel works such as no man had ever done before, He said, the nation would have been without sin in rejecting His claims. Even a Divine Revelation, then, appeals to the private, the personal, judgement, including the conscience and entire spiritual nature of those whom it addresses ; acknowledges their right, apart from authoritative interference by any one, to consider its claims, and throws on them the

responsibility of a decision. It may be called an awful right ; and it is certainly an awful responsibility. An inspired apostle sums up the logical conclusion when he says, ' To his own (the only) Master (Lord of the conscience) he standeth or falleth.'

Before proceeding further it may be well to explain that I use the term ' Higher Critics ' only in the sense in which it is now popularly bandied about—not meaning thereby critics who have brought criticism to bear on subjects which have been hitherto free from its scope, such as the origin of the books, the original text of the books, the meaning of the books—with everything external to the books and internal, that can throw any light upon them¹: but critics who by certain processes, whether legitimate or illegitimate, have come to the conclusion that all the ages until very recently have been entirely mistaken with reference to the authorship, and historical or non-historical character, of the five books which are the foundation of our Bible, and of certain other books as well. This criticism is in no proper sense higher or superior, nor are its advocates superior, nor its results. It does not

raise us to a plane of thought or knowledge that is in any sense higher. And when it claims to be historical we are reminded of a passage in one of Mr. John Bright's great speeches: 'He remarked, we are told, that Mr.—— seemed to read a different history from anybody else, or that he made his own history, and, like Voltaire, made it better without facts than with them.'

The reader may better understand what follows if reminded that the critics, whose position I contest, divide the legislation of the books which we call Mosaic mainly into three codes. The first is the Covenant Code, which is brief, and may be allowed to be really Mosaic, namely, *Exod. xx-xxiii*. The second is the Deuteronomic Code, consisting of the laws which are found in Deuteronomy, which belong, not to the age of Moses, but to an age probably some eight centuries later. The third is the Levitical or Priestly Code, which we find in the later chapters of Exodus, in the whole of Leviticus, and spread over some ten chapters of the Book of Numbers. This code, none of which, it is held, comes from Moses, was of gradual growth, and did not attain its present proportions till the time of Ezra.

PART SECOND

THE PLEA CONFIRMED BY THE CONSIDERATION OF REASONS WHICH ARE INDEPENDENT OF EXPERT SCHOLARSHIP

BEING then free, and bound to judge for themselves with such aids as are within the reach of ordinary thoughtful readers of Holy Scripture, non-experts are not without abundant material whereon to form an intelligent judgement respecting questions which some would take out of their hands and reserve for a favoured class, whom they would invest with a quasi-critical dictatorship.

FIRST OF ALL : **They cannot help being struck with the fact that the new theory would displace convictions which have come down unchallenged from the earliest Jewish age until what may be called yesterday.** These convictions have been ever regarded as facts, and as having been confirmed in the course of the ages by prophets and apostles and by the Lord of both.

According to the so-called Higher Criticism, it is maintained that ' the Books of Moses have been falsely

ascribed to him, and were in reality produced at a much later period. It is affirmed that the history is by no means reliable, and merely records the uncertain and variant traditions of a past Mosaic age ; and that the laws are not those of Moses, but the growth of centuries after his time.' We meet this averment by an appeal to the principle laid down by the commentator on Homer whom we have already quoted. After discussing the detailed and specific reasons which F. A. Wolf and others assigned for denying the unity of the *Iliad*, and the popular conception of its authorship, he says, ' We who stand on the received text have the tradition of long centuries in our favour, and not one substantial reason against us. Possession, in literary as in civil matters, is nine points of the law ; and he who wishes to shake an old received document out of its consistency, must be prepared to bring something more weighty to bear against it than clever guesses and well-devised possibilities ¹.'

In substance this argument of the learned professor holds good with reference to the Mosaic authorship of the Pentateuch and its legislation. We are as men '*in possession*, who have the tradition of long centuries in our favour.' 'It is an admitted rule of all sound criticism,' says Canon Rawlinson, 'that books are to be regarded as proceeding from the writers whose names they bear, unless very strong reasons indeed can be adduced to the contrary' (*Bampton Lectures*, p. 39). This rule applies to the

authorship of the *Iliad* and *Odyssey*, the *Aeneid*, the *Commentaries de Bello Gallico*, Xenophon's *Expedition of Cyrus*, and a multitude besides. 'These books do not bear their authors' names in the direct form in which a modern title-page declares an author's name. But the age to which they belonged believed in a certain authorship, and later ages have accepted and transmitted the belief.'

The critic may say that we beg the question when we assert that the tradition of Mosaic authorship can be traced to the age of the events which the books profess to record. But he cannot deny that the books themselves purport, sometimes explicitly, at all times implicitly, to be at least a contemporary record of the events which they record. Even Kuenen writes: 'It is not only the superscriptions that assign the laws to Moses and locate them in the desert, but the form of the legislation likewise accords with this determination and place. Now this may be explained in two ways: either the laws really come from Moses and the desert, or they are merely put into his mouth, and the desert and so forth belong to their literary form and presentment.' The latter alternative the critics choose. Moses was not the author. The laws were put into his mouth in after centuries. And the incidents, circumstances, and colouring of the desert are mere fiction, fabricated as a false setting for the purpose of giving effect to these laws, and thus investing them with an authority to which they had no right.

The bearing of these bold assertions of dishonesty on the part of the authors of the Pentateuch will be considered farther on. Meantime we have to do only with the acknowledgement that the testimony of the books themselves, whether true or false, is unmistakable.

Onward from the days of Moses to the days of Malachi, there are direct references to the statutes which lay at the foundation of the national polity, and other references, threatenings and promises, which pre-suppose the Mosaic legislation of the Pentateuch, and which are utterly unintelligible on the hypothesis that that legislation was not yet in existence. All this has been set forth elaborately by many writers. And the argument is valid that the silence of history during considerable periods of the nation's existence is no proof that Mosaic statutes were not observed; and if it could be proved that they were not observed, this non-observance would be no proof that they had not been given. In fact, the perpetual complaint of prophets was that their people had forsaken the law of their God, and had followed the devices of their own evil hearts.

Without attempting to trace the story of the book in detail, the reader's attention may be called to two or three marked epochs in the Jewish annals. David charged Solomon, not merely to keep certain laws which he ascribed to Moses, but to keep all that was 'written' in a certain book which was known as 'The Law of Moses' (1 Kings ii. 1-3). David must

have had this book in his hand when he celebrated the glory of God which the heavens declared to him as he shepherded his father's flock on the plains of Bethlehem, and when he celebrated with no less enthusiasm the statutes of the Lord which rejoiced his heart, which were more to be desired than gold, and in keeping of which there was great reward. Where did David find this law of the Lord? It must have come to him through the great judge and prophet of his age. And if we ask where Samuel found it, we must go back to find a possible beginning, from generation to generation till we reach the days of Moses.

Three hundred years after the days of Solomon we come to the reign of Hezekiah, of whom it is said that he kept the 'commandments which the Lord commanded Moses' (2 Kings xviii. 6). And within a few verses we are told that the King of Assyria carried away Israel unto Assyria 'because they obeyed not the voice of the Lord their God, but transgressed His covenant, and all that Moses the servant of the Lord commanded, and would not hear them, nor do them.' It is plain that the commandments of the Lord by Moses must have been in a book, and that this book was at this time in the hands of both Judah and Israel.

The greatest of the prophets ministered in the days of Hezekiah. And it is not a matter of mere inference that he must have regarded the commandments which Hezekiah kept so faithfully as the commandments of Moses, and the book which recorded them as the

book of Moses. A mistake on the part of Hezekiah would have been the mistake of Isaiah as well. In the book written by himself, Moses is named only in one passage (Isa. lxiii. 11-14), and that incidentally, and yet in a way which implies all that the preceding history ascribes to him as the leader of the people out of Egypt and in the wilderness. So that here we have another illustration of the *implicit* testimony of the prophets to the law of Moses.

The story of the finding of the book of the law in the house of the Lord, when the temple was being repaired, belongs to the reign of Hezekiah's great-grandson, Josiah, and is recorded in 2 Kings xxii and 2 Chron. xxxiv. The version of this story imagined by the Higher Criticism will be considered in a later chapter. At present we are only noting some principal epochs at which we find express mention of the law of Moses. There is nothing improbable in the account of the matter. The reign of Josiah's grandfather, Manasseh, had extended over more than half a century, and was distinguished by a virulent spread of idolatry, by the most cruel persecution of the faithful, and the most outrageous profanation of the sanctuary. Manasseh's son, Amon, served the idols which his father had for a brief season forsaken. And to this long inheritance of corruption Josiah succeeded when he was only eight years of age. Hezekiah's copy of the law, written according to the requirements of Moses, made seventy-five years before the reign of Josiah, was most probably destroyed during the fierce persecutions of the reign

of Manasseh. And there is nothing strange in the supposition that Josiah had not seen a complete copy of the Pentateuch till it was found by Hilkiyah, the high priest.

When we come to the days of Ezra and Malachi we find express mention of the law of Moses on the return of the exiles under Ezra, and still later in the last prophetic writings of the Old Testament. Even if there were more lapses of silence than there are in the history, the words of Malachi are conclusive evidence of the existence of the Mosaic origin of the Pentateuch, of at least a portion of it which is now the matter of dispute. 'Remember ye the law of Moses My servant, which I commanded unto him in Horeb for all Israel, with the statutes and judgements.'

The identity of the book which we call the law of Moses, and which we find mentioned in the several instances which have been quoted, and in many others, may be illustrated by a familiar example. Bede wrote his *Ecclesiastical History of the English Nation* about the year 730 A.D. Suppose we found a reference to Bede's *Ecclesiastical History of the English Nation* in 1230 A.D., and another in 1430 A.D., and another in 1630 A.D.; we should conclude that the book referred to was one and the same, unless some strong and strange evidence was forthcoming that the original book had been destroyed or lost, and that a spurious production, a forgery, in fact, had taken its place. Why not accept on the same principle the fact of the identity of the Law of Moses from the beginning? The words

of Malachi may justly be regarded as a final confirmation of earlier prophetic words, a summing up of the witness of many ages.

The four centuries which separated Malachi from Christ were far from being what they seem to many readers of the Bible—a great historic blank. They were most eventful in the external relations of the Jews to the Persian Empire, the Macedonian Alexander and the growing Roman power. And they include specially an event which made the sacred books of the Jews accessible to the civilized world outside their own nation, the translation of these books into the language which the conquests of Alexander had made wellnigh universal, or at least universally understood so far as book-learning was concerned. The exact date or dates of the translation, the persons of the translators, and the immediate occasions or motives of the work may be matters of some controversy. But the Septuagint is a fact of great moment, and it comes to us from the age of which we have no Biblical history. Whatever may be its imperfections or errors, it bears witness to the continued existence of the book two hundred or two hundred and fifty years after Malachi, and it was sufficiently true to the original Hebrew to gain general acceptance among the Jews themselves. So that in the time of Christ we have the Old Testament in its primitive form held most sacred, and with impunity not to be tampered with, and in a translated form which became to a large extent the popular Bible. Christ had both in His hands, the original

certainly, which alone was read in the synagogue worship. The deductions which we draw from the fact that He did not challenge its integrity or its authority will be considered in another chapter. We are now only tracing the existence of the book, the book which begins with Genesis and the early Mosaic history of the people of Israel and ends with the prophecy of Malachi. We need not trace it farther. From henceforth it was under the guardianship of both Jews and Christians, or rather of Him who was the Divine Angel of the Old Covenant and is the Divine Lord of the New.

It will now be seen with what entire confidence we may adopt the argument of the Greek scholar, who, while willing to appraise and discuss every objection which the ingenuity of Wolf and others could allege against the Homeric authorship of the *Iliad*, argued that 'the tradition of long centuries' was not to be set aside by 'clever guesses and well-devised possibilities.' On this ground alone the case in support of the Mosaic origin of the law and of the books which contain it, is immensely stronger than that in support of the reputed traditional origin of any other ancient book. Had we only such evidence, partly explicit and partly implicit, as may be gathered from the writings of the Son of Sirach¹, Philo, Josephus, and

¹ The Son of Sirach, the author of the book known in the Apocrypha as 'Ecclesiasticus,' who wrote from B.C. 200-150, was familiar with the classification of the books as the Law, the Psalms, the Prophets. Philo, in Egypt, in the age of Christ

others, it would be of a kind with that which guarantees to us the authenticity of other ancient books, and it would be difficult to resist its historic validity. We have all this in the case of the Bible books whose origin we are considering. But we have a great deal more, a distinctly divine tradition, which lifts them to an altogether higher plane.

Himself, wrote large commentaries on the Old Testament. The very specific testimony of Josephus, who wrote after the destruction of Jerusalem, may be given in full: 'We have not a countless number of books, discordant and arrayed against each other, but only *two-and-twenty books*, containing the history of every age, which are justly accredited as divine [old editions of Josephus read merely, 'which are justly accredited'—*θεῖα* comes from Eusebius' transcript of Josephus in *Ecccl. Hist.* iii. 10]; and of these, *five* belong to Moses, which contain both the laws and the history of the generations of men until his death. This period lacks but little of 3,000 years. From the death of Moses, moreover, until the reign of Artaxerxes [Eusebius—'from the death of Moses to that of Artaxerxes'; and so most of the Codices, omitting ἀρχῆς, reign], king of the Persians after Xerxes, the prophets who followed Moses have described the things which were done during the age of each one respectively, in *thirteen* books. The remaining *four* contain hymns to God and rules of life for men. From the time of Artaxerxes, moreover, until our present period all occurrences have been written down; *but they are not regarded as entitled to the like credit with those which precede them, because there was no certain succession of prophets.* Fact has shown what confidence we place in our own writings. For although so many ages have passed away, no one has dared to add to them, nor to take anything from, nor to make alterations. In all Jews it is implanted, even from their birth, to regard them as being the instructions of God, and to abide steadfastly by them, and, if it be necessary, to die gladly for them.'

SECONDLY : The unlearned reader of Holy Scripture may well stand in doubt of a theory which, to say the least, places the testimony of Christ in a very ambiguous position.

Why I bring the testimony of our Lord into the foreground, instead of reserving it to confirm other arguments, will appear as we proceed. The materials for a judgement regarding it are spread over the four gospels, and, were it not that difficulties have been raised or suggested, one might say boldly, 'The man may read that holds the plough.' Without controversy, it may be said, that the learned and unlearned stand on the same level in regard to it. There are no various readings and no various translations to require a verdict on the part of experts. Even with reference to the apostolic words in Phil. ii. 6-8, which have been brought into prominence in relation to the subject, scholars are agreed as to the fittest translation, and we have it in the Revised Version. The bearing of the apostle's words on the condition of Christ in His humiliation is to be determined, not on speculative grounds, but in the light of the facts of His life, which lie before us in the gospels 'without a veil.' The reverent reader and learner turns to these facts, to ascertain whether Christ pronounced any judgement on those Scriptures whose origin and authorship are at present in dispute, and what that judgement was.

1. It is not denied that the Old Testament, as we have it, was in all substantial respects the scripture or scriptures which Christ and the generation to which He belonged held in their hands, and which were read in their public Sabbatic worship. Even if we accepted the Higher Critical theory, it would still be true that our Old Testament in its entirety was anterior to the days of Christ, and that it was Christ's own Bible.

2. It is not denied that Christ was intimately familiar with the contents of His Bible. In conversation with His disciples and in discussions with the Jews, He had occasion to refer to facts and sayings that are scattered over the Old Testament from the first verses in Genesis to the last in Malachi¹.

3. In our Lord's references to the Old Testament it is important to observe (1) that in no instance did He quote from books not found in our Bible or from oral tradition; and (2) that there are books in our Bible from which He did not quote, or at least of which there is no record that He quoted. This is easily accounted for. His recorded quotations from the Old Testament were incidental, i. e. as occasion arose through circumstances, and through questions and objections on the part of the people or on the part of disciples.

4. In addition to specific facts and books, Christ, especially after His resurrection, placed the seal of His authority on the entire collection, under designations by which it was popularly known, such as the law, the prophets, and the Psalms (Luke xxiv. 44). 'Beginning at Moses and all the prophets, He expounded unto them in all the scriptures the things concerning Himself' (Luke xxiv. 27). Would, we naturally exclaim, that the evangelist had recorded the gracious and precious words in which Christ traced Himself from the beginning to the end of the ancient scriptures ! But with the key to these scriptures which He supplied—Himself the mystery which has been veiled for ages—and with the fact that He opened the understandings of His disciples to understand what He told them, we may be sure that the gospel records are in no sense misleading as to His Person and His Mission, and equally sure that the teachings of His apostles, to whom He promised the guidance of the Holy Spirit, were in entire accordance with His own words. Searching the Scriptures for ourselves, it is a matter of the deepest interest that we can find Him unveiled in the very earliest of them, as the seed of the woman who should bruise the serpent's head, and in the very latest of them as 'The LORD,' 'The Lord of hosts,' who should suddenly come to His temple—these two prophecies binding, not by accident, but by Divine purpose, into a grand consistent whole, those revelations which had been given, at sundry times and in

divers manners, through at least four millenniums of fallen man's existence on the earth.

5. There is another fact which lies prominently on the face of the gospel records, this, namely, that Christ spoke with conscious authority. This authority may be described as both delegated and personal. Of His delegated authority He spoke with frequent emphasis. 'The word which ye hear is not Mine, but the Father's which sent Me.' He stood before His countrymen in Galilee and Judea, visibly only as Jesus of Nazareth. Hence it was that when the Jews marvelled and said, 'How knoweth this man letters, having never learned?' Jesus said, 'My doctrine is not Mine, but His that sent Me.' And yet the very terms in which He thus disclaimed a personal, i. e. in this case a human, a merely human, origin and authorship for His doctrine, pointed to something in His underlying personal relation to His doctrine very different from the relation in which prophets stood to theirs. The difference between Christ and the prophets was not one of degree merely, the difference between a partial and what has been called a 'complete endowment of manhood,' such as is indicated in the statement that God gave not the Spirit by measure to Him. His was a personal authority, such as neither prophet nor apostle dared to assume. Standing before the multitude with the clear memory of all the Divine teaching which the nation had enjoyed for ages, and of Divine pronouncements against such as claimed authority unauthorized, and

with a full knowledge of great contemporary interpreters of the law, and of men of the immediately preceding age, of whom the nation was proud and in whom the nation trusted—standing there in spiritual majesty and conscious of all that His words involved in relation both to God and to man, He repeats, through every point of His exposition of what had been said to them of old, this, and this only, ‘I say unto you.’ If man never spake like this man, it is because never before was there man like this man. How else could He say, ‘Heaven and earth shall pass away ; but My words shall not pass away’ (Luke xxi. 33) ?

6. We may assume as a fact, although some would call it an inference or deduction, that Christ regarded the Old Testament incidents which He quoted, and on which He based arguments or lessons, not as myths or fables or allegories or uncertain national traditions, but as historically true and real. Beginning with the creation of man and woman and the primitive law of marriage, we read the story of His references onward till we come to His recognition of the foretelling of the coming of a prophet in the spirit of Elijah ; and we find no room in His words for legendary or allegorical hypotheses. Abel, Noah, Abraham, Moses, Elijah, Jonah, and Daniel, were regarded by Him as real personages ; and if the incidents which He quotes, such as the death of Abel, the Flood, the burning bush, the brazen serpent, the ministry of Elijah in the reign of Ahab, the mission of Jonah

to Nineveh, and the prophecy of Daniel respecting Himself, were not realities, and are not truthfully narrated, He was mistaken.

7. If this be granted, it can scarcely be denied that Christ regarded the books from which He quoted as truthful and trustworthy. The facts and sayings which He quoted cannot be isolated from the connexions in which they stand. They are not aphorisms whose truth is in themselves, and which would be true even if spoken by the Devil, as nuggets of gold are gold even if found in a mass of rubbish. The ground on which Christ requires His hearers to accept them, apart from His comments and interpretations, is that they found them in the written law of the Lord. 'Have ye not read?' or 'It is written,' is the ground of His constant appeal. The acknowledged authority of the 'written' and 'read' book constituted with His hearers sufficient and undisputed authority for the words which He quoted from it.

This being so, I do not see how it can be logically questioned that every one of the five books of Moses bears the seal of Christ:—that of Genesis, when, with reference to the law of marriage, He said, 'Have ye not read?' (Matt. xix. 4); that of Exodus, when He said 'Have ye not read?' with reference to the words of God to Moses out of the burning bush (Matt. xxii. 31 and Luke xx. 37): that of Leviticus, when He instructed the leper to obey a law of Moses found only in Leviticus; that of Numbers, when He referred to the

brazen serpent which Moses lifted up by Divine command; an incident to be found only in Numbers (John iii. 14); that of Deuteronomy, which Christ quoted three times with the formula, 'It is written,' in His conflict with the Tempter (Matt. iv. 4, 7, 10). The seal put thus on the Book of Deuteronomy is of more than argumentative interest. In the awful solitude of His conflict with the Tempter, in the hour which in some respects was the most critical in the history of redemption, the Son of God, whose consciousness of Himself could not be shaken by the Tempter's insinuation of the doubt, does not at once put forth the power which could have smitten His adversary, not into silence merely, but into helplessness. He falls back on written words which had been light and strength to the saints of many ages, thus associating Himself with the redeemed of the past and of the future, His 'brethren' (Heb. ii. 11, 17, 18), and instructing them how to meet and foil the adversaries of their souls. Was the book which it is evident had yielded spiritual nourishment to the Son of Man, while yet He had not entered on the public discharge of His Divine ministry, and by which now at the very commencement of His public life He quenched the subtle darts of the Wicked One (Eph. vi. 16), other than what it professed to be, a very record of an important epoch in the history of God's ancient people, and of words addressed to them by Divine authority on the eve of their entrance on national existence in a land

which would be to them a scene of manifold temptations?

But there is still more to be said as to the bearing of our review of Christ's testimony on the question of the age and authorship of the legislation and books which have hitherto borne the name of Moses.

The first thing that strikes us is that Christ did not challenge the national belief in the origin of the oldest even of their sacred books, and in the authority which they derived from their supposed connexion with the man whom they regarded as the very founder of their national constitution. This fact by itself, explain it as you will, is no mean presumptive evidence that they were right in their belief. If they were wrong, they were dominated by an error which was fundamental, and which could not but vitiate their spiritual life and mis-direct their obedience to the Divine will. Christ, we know, was in perpetual conflict with the chief sects of the nation, Sadducees and Pharisees, and with popular sentiment as well. The people often listened gladly to His gracious words, but their opposition, and even bitter hostility, were as often excited by sayings which they considered hard, and which offended their national pride and worldly hopes. The most superficial acquaintance with the pages of the gospels reveals Him as a severely independent and uncompromising Teacher. He boldly combated the most cherished Jewish notions. How came it to pass

that He spared the great error, if error it was, which the people of His age had inherited from their fathers, and thus passed it on from the Jewish age into and through the Christian age, to be discovered at last only by the penetrating and uncompromising intellects of these last days? The only conclusion we can come to, if the honour of Christ is to be preserved unsullied, is that He did not challenge the national judgement because it was a true judgement. He was Himself the Truth, and only truth found favour with Him.

Let it not be imagined for a moment that the correctness or incorrectness of the national belief was a matter of little or no consequence in relation to Christ's own work and mission; in other words, that the testimony of the books to Him was equally valid, whether they had genuinely come from Moses or had been fabricated—possibly for a good end, the end justifying the means—some of them towards the end of that dispensation which an apostle regarded as a schoolmaster¹ to lead on the Jewish people to Christ. We have good reason for saying that Christ Himself did not think so. There is a sense in which His Messiahship, His title to the Messiahship, depended

¹ The Revised Version (Gal. iii. 24) says 'tutor' instead of 'schoolmaster.' on the genuineness of these ancient scriptures, that is, on the fact that their prophetic witness to Him had the authority of God Himself through His most honoured (see Num. xii. 7, 8) servant, Moses.

In nothing does what we may call the independence and originality of Christ appear so significantly as in the matter of the Messiahship. Both He and the people believed in a Messiah to come ; both believed that the Messiah was foremirrored in their sacred books, and that whosoever claimed the office must make good his title out of these books. But their reading of the books did not result in the same conclusions as to what manner of person the Messiah was to be, and what manner of benefits He should confer on His nation. The people, groaning under a foreign yoke, and reading their Scriptures under the influence of a worldly spirit which could imagine, and aspire after, no higher blessing than national freedom and supremacy, concentrated their thoughts on predictions which foreshadowed the power, dominion, and glory of the Messiah. Consequently 'they expected (to use the words of the author of *Ecce Homo*) to see once more a warrior king, judging in the gate of Jerusalem, or surrounded by his mighty men, or carrying his victorious arms into the neighbouring countries, or receiving submissive embassies from Rome and Seleucia, and in the meantime holding awful communication with Jehovah, administering His law, and singing His praise. It was as impossible for them to conceive the true Christ, to imagine what He would

do, or how He would do it, as it was impossible for them to fill His place.'

Both before and after Christ there arose men who were in sympathy with the national spirit, and were bold enough to present themselves to their people as the embodiment and realization of the national hope. But their work soon came to an end.

Jesus of Nazareth, brought up in, and breathing for thirty years, the feverish atmosphere of Galilean expectations, was conscious of a Messiahship of another order. It was quite natural for His countrymen, when they witnessed the mysterious power with which He could feed thousands, a power which had its parallel only in that which fed the multitude of Israel in the wilderness, and which they associated with the name of Moses, to conclude that He was fit to take the kingship that would secure the victory and freedom for which they longed. But He would not have it. And yet He was a king, and knew it, and boldly avowed it even in the presence of the representative of all-powerful Rome, and that when He seemed Himself to be the most helpless of men.

But how different His kingship from that of popular expectation! We may well wonder that He was able to separate Himself so absolutely from the spirit of His age and nation. And we may wonder likewise that one brought up in the meanness and poverty of a carpenter's home, should see in Himself or imagine that He was the One in whom four milleniums of prophecy culminated, and in whom all the

nations of the earth were to be blessed. The secret of His knowledge is to be found in Himself, in His consciousness of what He was. But how should the people know? How should their eyes penetrate through the cloud which hid His glory, and which seemed to render the existence of any such glory impossible? He did not ostentatiously or even prominently proclaim His Messiahship and His Divinity. From the first He allowed disciples to render Him homage as the Messiah and the Son of God (John i. 43-51). And on an occasion which has become memorable, though one would imagine it the least likely, He made an express declaration of the fact (John iv. 25, 26). But for the most part He left what He was, to be inferred and proved by His works, His teaching, and His character. Above all, it was necessary that He should not shrink from an appeal to the books, which, though much misunderstood, were the true ground and the true test of the Messianic hope. And this appeal He made boldly. 'Ye search the Scriptures,' He said, 'and they are they which testify of Me' (John v. 39). Of these Scriptures He made special and emphatic reference to the writings of Moses; and this reference is of first importance. It is often slurred over by saying that Christ might describe a book, as we often do, simply by the name of its reputed author. But no escape can be found in this idea from the unmistakable force of these words: 'Had ye believed Moses, ye would have believed Me; for he wrote of Me. But if ye believe not his writings, how shall ye

believe My words ?' (John v. 46, 47). The traditions with which the Pharisees overlaid the laws and teachings of Moses He branded as making the word of God of no effect (Mark vii. 13). But the *writings* of Moses, unadulterated by tradition, were worthy of the confidence which the people placed in them. *Their* authority rested on the fact that they *were* the writings of Moses, the servant of God. And if Christ did not so believe, He was seeking support for His claims in a popular fallacy, a popular misbelief—this, viz., that it was Moses, whom the people revered as possessed of Divine authority, that had written those things concerning Him which He found in the earlier books in the Old Testament. We have here something very different from a mere casual or incidental quotation of an ancient book by the name of its reputed author. We have a solemn argument and remonstrance based on His and the people's belief in the Mosaic authorship ; in fact, an unqualified testimony to Moses as a prophet, a lawgiver, and a writer. To the spirit of this appeal we have a very solemn confirmation in the parable of the rich man and Lazarus. The rich man appeals to Abraham on behalf of his brothers, and Abraham says to him, 'They have Moses and the prophets ; let them hear them. If they hear not Moses and the prophets, neither will they be persuaded, though one rose from the dead' (Luke xvi. 29, 31).

In the matter of Christ's testimony we cannot overlook the fact that He associated the name of Moses expressly with scriptures which are now

declared not to have been his. For example, to a leper whom He had healed He said, 'Go thy way, shew thyself to the priest, and offer the gift that Moses commanded' (Matt. viii. 4). Now the command of Moses is to be found in the very heart of that priestly code which the critics say was framed centuries after the days of Moses. The law concerning leprosy occupies two long chapters in the Book of Leviticus, the thirteenth and fourteenth. It is prefaced thus: 'The Lord spake unto Moses and Aaron, saying;' and this preface is not peculiar to the law of leprosy. It would be only the 'foolishness' of argument to limit the testimony of Christ to the one law to which He had occasion to refer when He instructed the healed man to do what Moses had commanded. Immediately before and immediately after this law, we have other laws introduced in the same words. And if the one came from Moses, so did the others.

We find Christ associating Moses personally with incidents to which He referred, as in Luke xx. 37 and John iii. 14. And it is worthy of notice how He distinguished the part which belonged to Moses and the part which did not, in matters with which he was connected. Thus, referring to circumcision, He reminded the Jews that it did not originate in a law of Moses, Moses having to do only with the day on which the rite was to be performed (John vii. 21, 22; Lev. xii. 3). And as to the law of marriage, the part which prescribed the giving of a bill to

a divorced woman alone belonged to Moses (Matt. xix. 7 ; Deut. xxiv. 1). One of the laws which Christ thus ascribed to Moses is found in the Levitical or priestly code, and the other in the book which they say was written hundreds of years after his time.

The reader of the Gospels cannot fail to receive the impression that in all Christ's conversation with the Jews, our Lord regarded Moses not as a mere title by which certain books were known, but as personally the actor in the history which they record, and the author of the legislation which they contain : ' Did not Moses give you the law (Christ said), and yet none of you keepeth the law ? ' (John vii. 19). ' We are Moses' disciples (the Jews said to the man to whom Christ had given sight). We know that God spake unto Moses : as for this man, we know not whence he is ' (John ix. 28, 29, R. V.).

This faith in Moses, as the responsible author of the books which bear his name, was inherited by Christ's disciples. The apostle John says expressly, ' The law was given by Moses ' (John i. 17). And the apostle Paul specifies the very date at which Moses gave the law. It was four hundred and thirty years after the great promise of blessing and grace to mankind was given to Abraham (Gal. iii. 17). In fulfilling their mission ' to the Jew first,' the apostles invariably appealed to Moses and the prophets. ' Moses,' James reminded his brethren (Acts xv. 21), ' of old time hath in every city them that preach him, being read in the synagogues every

Sabbath day.' And in every synagogue to which the apostles had access their concern was to show out of the Scriptures that Jesus was the Christ. In doing this they began, as Christ Himself had done, with Moses. If the scriptures of Moses were not genuinely his, the apostles were either deceivers or deceived. And if the Messiahship of Jesus of Nazareth could not bear an appeal to Moses and the prophets, the Jews were entitled to reject Him.

What shall we say to all this—what that can throw doubt on, or minimize, what seems at least to be conclusive evidence that our Old Testament comes to us with, to use a modern phrase, the imprimatur of the Son of God Himself? Some have a vague impression that the testimony of Christ will be materially modified when judged in the light of the apostolic words now translated thus: 'Who, being in the form of God, counted it not a prize to be on an equality with God, but emptied Himself, taking the form of a servant' (Phil. ii. 6, 7); but is it so? Kenotic theories which are offered to us to explain the inner meaning, the essential contents, of the words 'He emptied Himself,' all leave us unsatisfied and with a feeling that the mystery of the Incarnation and of its effect on the condition of the Incarnate One must remain a mystery. From all attempts at abstract definition we turn aside to the concrete history of the Son of God in the days of His flesh as we have it in the Gospels. What

that history tells us on the subject we are now considering is too plain to be mistaken. And reverent expounders of Kenotic theories themselves do not hesitate to say that, whatever amount of truth may be in them, it is certain that not only was Jesus Christ an infallible Teacher, but that He was 'incapable of misleading.'

If we are asked whether Jesus Christ Himself did not confess to a limitation of knowledge, we reply that He did on one occasion and as to one thing: 'Of that day and that hour knoweth no man, no, not the angels which are in heaven, neither the Son, but the Father' (Mark xiii. 32). The proper inference from these words is, not that there might be many other things which He did not know, but that if there were other things which He did not know, He would have made the like confession instead of this. We find Him actually claiming a knowledge far more wonderful than that which He disclaimed: 'All things are delivered unto Me of My Father: and no man knoweth the Son, but the Father; neither knoweth any man the Father, save the Son, and he to whomsoever the Son will reveal Him' (Matt. xi. 27). The 'all things' delivered to Christ by the Father are explained in part at least by words used on other occasions—'All power,' 'all judgement,' the forgiving of sin, and the giving of life. Need we wonder that the apostle Peter should say to Him, 'Lord, Thou knowest all things' (John xxi. 17)? The apostle might be puzzled by metaphysical questions as to omniscience.

And yet he would not withdraw his words. He had seen enough and heard enough practically to anticipate the claim which Christ asserted for Himself to John in Patmos: 'I am He which searcheth the reins and hearts' (Rev. ii. 23). Christ had often detected the unspoken thoughts of His disciples and of the scribes. He discerned from the beginning the heart of Judas, and knew that he would betray Him. He prophesied the denial of Peter; He foretold His own death and the manner of it, His resurrection on the third day, and His ascension; He foretold the siege and destruction of Jerusalem, and He foretold what is yet future to us, and is therefore still unaccomplished. 'If in all this and much more there was not displayed (as Canon Rawlinson says) a Divine consciousness, knowledge more than human, it is difficult to see how such knowledge could have been manifested'—knowledge, be it observed, which was His while in that state which is described and covered by the apostolic words, 'He emptied Himself, and took upon Him the form of a servant.'

It seems almost trifling with a great and sacred subject to suggest that Christ might have chosen to be ignorant, or to pass by, as unworthy of notice, so unimportant a matter as the authorship of certain books. With all reverence we may say that He could not have so chosen. And we have evidence that He did not so choose. There is no element of reality in the favourite formula, 'critical and literary questions' which might have been left to later ages, that was

not included in our Lord's averment touching the 'writings of Moses.' At the risk of some repetition let me say, in the words of Professor Cheyne, that Christ could not have mistaken the meaning of His own Bible. The profoundest critical and exegetical question which had to be solved was the true meaning of ancient prophecy. Christ solved it; and His argument with the Jews involved the solution of the further critical and literary question, who wrote certain books in which prophecy respecting Him was found? *He said it was Moses.* The authorship was an essential part of His argument.

THIRDLY: The reverent and believing Bible reader may well recoil from the processes of the Higher Criticism because of their moral implications and bearings.

No wider gulf can be found or imagined between the ordinary reader, whose spiritual senses have been exercised to discern good and evil in the matter of honesty and truthfulness, and the criticism which necessitates a charge of untruthfulness and imposture against the writers of large portions of the Old Testament. I am well aware that there are critics who deny that this charge lies fairly against their theories. They repudiate the word forgery, and imagine what they would call scientific explanations of what to the common mind looks very like forgery. But the common mind recoils from the special pleading which

their case needs, and is disposed to apply to it the words of the prophet, slightly altered for the occasion, 'Though thou wash thee with nitre, and take thee much soap, yet thine iniquity cannot be washed away.' Let any reader, common or uncommon, read without note or comment, the twenty-second chapter of 2 Kings and the thirty-fourth of 2 Chronicles. He can judge of their meaning as well as the most learned scholar. When the temple is being repaired in the days of good King Josiah, a book is found, which in Kings is called 'the book of the law,' and in Chronicles, 'a book of the law of the Lord given by the hand of Moses.' Hilkiah the high priest, who found it, sends it by Shaphan the scribe to the king, who, on reading it or some portion of it, sends the high priest and some others 'to enquire of the Lord concerning the words of the book.' They go to Huldah the prophetess, and 'commune with her' on the subject, and she confirms the threatenings of the book because 'Their *fathers* had not kept the word of the Lord, to do after all that was written in this book.'

All this seems very plain. The book that was found was 'the book of the law which was given by Moses.' Even if it was called, as in Kings, only 'the book of the law,' nothing else could be meant than that it was the book of the law of Moses. The '*fathers*' had had this book in their possession, for their sin was that 'they had not kept the word of the Lord, to do after all that was written in this book' (2 Chron.

xxxiv. 21). This was the understanding of the high priest, the scribe, the prophetess, and the king. *Or they pretended that it was.* The critical theory is that the book was what is known to us as the Book of Deuteronomy, and that it was written, not in the days of Moses, but now, in the days of Josiah, to aid Josiah in the reformation on which his heart was set. Dr. Driver prefers to think that it was written in the days of Manasseh, Josiah's grandfather. But this makes no difference in the moral character of the transaction. Whoever wrote it in either reign was guilty of a fraud. If the finder of the book was not himself the author of the book, he was easily imposed on—that he should accept as by Moses, containing laws and threatenings which professed to be of Moses, a book which the '*fathers*' had never seen, a book against which the fathers, not having seen it, had not sinned. One wonders too at the simplicity of the idolatrous multitude and their idolatrous leaders, that they should be frightened out of their evil but much-loved ways, by threatenings of judgement, which, they could easily prove, had not been heard of till some unknown contemporary had falsely put on them the seal of Moses!

The glosses which are put on this supposed transaction to hide its nakedness may be set aside, in view of the boldness, one might say the nonchalance, with which the critics ignore the plainest and most unmistakable historic statements of the book, and substitute for them their own subjective impressions. Take an example. The great song, worthy even of the great

Moses, and which is associated with the 'song of the Lamb' in Rev. xv, which occupies the thirty-second chapter of the Book of Deuteronomy, is prefaced thus: 'Moses spake in the ears of all the congregation of Israel the words of this song, until they were ended.' The prophetic forecasts of the future of the tribes which we find in the thirty-third chapter are prefaced thus: 'This is the blessing, wherewith Moses the man of God blessed the children of Israel before his death.' But these positive and specific averments are as if they were not—of no account in the way of Dr. Driver's criticism. He will judge for himself when and by whom this 'song' and this 'blessing' were written. And his judgement is this: 'The song shows great originality in form, being a presentation of prophetic thoughts in a poetical dress, which is unique in the Old Testament. The standpoint, whether assumed or real, from which the poet speaks is subsequent to the Mosaic age, to which (in vv. 7-12) he looks back as to a distant past. The theme is developed with great literary and artistic skill; the images are varied and expressive; the parallelism is usually regular and very forcible.' Dr. Driver's only doubt is whether the song is by the same hand as the body of the book. The internal evidence, he thinks, does not absolutely preclude its being by the same author, but 'the contents hardly leave it a possibility.'

I am not concerned to reply to this criticism. Only I may remark that it is rather strange that the 'great literary and artistic skill' of the unknown author

of this composition did not save him from putting into the mouth of Moses words, in which Dr. Driver discovers an anachronism which proves it to have been written 'after the Mosaic age'—a great blunder surely on the part of so skilled a writer. My object is to show how the Higher Critical theory of the book necessitates the admission of untruthfulness at every point. The book may say that a certain composition, full of solemn truth and admonition (xxxii. 44-47), was written—all the words of it to the end (xxxi. 30)—by Moses. No, says the critic; this is to be ascribed to the literary skill and art of the author, unless indeed it was interpolated by some 'redactor' who found the song somewhere and tacked it on to the book. From such methods of interpretation the reverent reader recoils with the conviction that if the Old Testament is true, the theory is an offence to both the intellect and the conscience of its trustful readers.

But if we would have an adequate sense of the extent of untruthfulness and deception of which the Book of Deuteronomy is guilty according to the 'critical theory' so called, we must read the book from beginning to end, and pause over its many averments respecting its own contents, and compare them with the averments or implications of the theory which denies the Mosaic authorship. The very first sentences of the book are these: 'These be the words which Moses spake unto all Israel on this side Jordan in the wilderness, in the plain over against

the Red Sea, between Paran, and Tophel, and Laban, and Hazeroth, and Dizahab. (There are eleven days' journey from Horeb by the way of Mount Seir unto Kadesh-barnea.) And it came to pass in the fortieth year, in the eleventh month, on the first day of the month, that Moses spake unto the children of Israel, according unto all that the Lord had given him in commandment unto them; after he had slain Sihon the king of the Amorites, which dwelt in Heshbon, and Og the king of Bashan, which dwelt at Astaroth in Edrei: on this side Jordan, in the land of Moab, began Moses to declare this law, saying, The Lord our God spake unto us in Horeb, saying'—and so on.

If it be true that the book was written in the days of Josiah, nine hundred years or thereabouts after Israel entered Canaan, or possibly somewhat earlier, in the days of Josiah's grandfather, and that the addresses to the people which it puts into the lips of Moses were manufactured for a purpose by some unknown genius nearly a millennium after the days of Moses; and, moreover, that the incidents and circumstances which introduce these speeches, and the recital of principal events which are said to have occurred during the forty years in the wilderness which occupy the earlier chapters of the book, are not real, except so far as vague traditions which may have survived for nearly a thousand years may have suggested them—not real, but imagined and invented to give plausibility to the speeches—how shall we

characterize the book's own description of its contents? How would a judge in a court of law describe it? Would he hesitate to say that if the true history of the book be what certain critics allege, the preface to the book is nothing short of a lie? He would scarcely have patience to listen to explanations or apologies. Let him read the book for himself, and he will tell the men at his bar that the lie which is told on the frontispiece of the book pervades it from the beginning to the end. Not a lie—the apologist the special pleader, will say—the book is constructed after the manner of classical historians, 'who put fictitious discourses into the mouths of their principal characters, not with any intention to deceive, but simply for the purpose of throwing light on the historical situation.' But in this instance is it not of the very essence of the critical theory, that it was the object of the writer or writers to make the people of the days of Manasseh or of Josiah believe that Moses had spoken the words which they put into his mouth—to give these words greater authority than they would otherwise have, as a protest against idolatry and as a plea for the worship of Jehovah? The ascription of the words which we find in the book to Moses, was, on this showing, a bold conscious falsehood; and the writers took every precaution to prevent its fictitious character from being discovered. They specified the very year, the very month, the very day of the month, on which they said Moses began to speak what the book records (Deut. i. 3). And to make

their readers feel quite sure that they had the very words of Moses in the book and no others, they represented him as saying, 'Ye shall not add unto the word which I command you, neither shall ye diminish ought from it, that ye may keep the commandments of the Lord your God which I command you' (ch. iv. 2).

Nothing can save the writers of this book, if they were, as the critical theory says they were, men of the days of Manasseh or Josiah, from the charge of conscious and painstaking forgery. This, every one feels, is an ugly word. But all its ugliness and consequences must be faced by the learned men who deny the book's own statement of its origin and character.

Colonel Conder has no hesitation in saying, 'We have no knowledge of a Jewish scholar mutilating the writings of his ancestors, or of his composing a book of fragments from unacknowledged sources, linked together by a few words of his own writing. That kind of bookmaking is characteristic rather of our own times; and no editor who so presented to us, as the law written by Moses, a composite later forgery could escape the charge of literary dishonesty' (*The Bible and the East*, p. 90).

As to the examples of classical historians to which we are referred, who put speeches into the mouths of their characters, 'not to deceive, but to throw light on the historical situation,' when we turn to Deuteronomy we find the speeches not throwing light on the historical situation, but the historical situation throwing light on the speeches. The speeches grow

out of the occasions and incidents which the book records, and if either be unhistorical, the other must be likewise. 'To most of us,' says Principal Douglas, 'a remarkable voucher for the truth of the book is the interlacing of the history and the legislation throughout the whole Pentateuch, so that we feel the utmost difficulty in conceiving how the one should have come into existence without the other' (*Lex Mosaica*, p. 59).

The Book of Leviticus shares the fate of the Book of Deuteronomy in the hands of the Higher Critic. Some of its ordinances, he admits, may be based on practices which had somehow already come into existence, but these practices were not based on any Mosaic law. That there is not the shadow of historical authority for implicating Ezekiel and Ezra or any of their contemporaries in the creation of the priestly code, is patent on the face of the books which bear these honoured names. Let it be remembered that the most advanced scholarship has no advantage over the non-expert in forming a judgement on this matter, and that the non-expert is quite capable of appreciating the general grounds on which the Mosaic authorship of Leviticus may be maintained, as these are stated by Canon Rawlinson thus: (1) 'The Levitical code is such a law as Moses, from his position and the circumstances of his time, might have been expected to promulgate; (2) That it is such a law as the later history of the people of Israel

postulates and requires; (3) That the human testimony to the fact of Moses having given this law is amply sufficient to establish it, being extraordinarily full and varied; and (4) That the fact rests not merely, as most facts, on human evidence, but also on a witness who is Divine' (*Lex Mosaica*, p. 21).

Our present argument, however, has to do only with the moral implication of the critical theory. Opening the book and reading from beginning to end, we find that all its ordinances and precepts are prefaced by the solemn words, 'The Lord spake unto Moses.' These words occur some thirty times in the book; these thirty assertions are, according to the theory, thirty falsehoods, and these thirty falsehoods and others of their kind in other books were—one hesitates to write it even hypothetically—written deliberately by holy men, unknown worthies, to create and exalt an order of priests which had not existed before at least by Divine authority; and, it may be (sanctifying the lower motive by a higher) at the same time, the better to secure obedience to the Divine will. The supposition is so gross that it may be rejected at once, not without some indignation, by the moral sense of Bible readers.

One other instance, incidentally referred to already, in which the non-expert reader is struck with the boldness with which criticism deals with plain historic statements, and practically treats them as untrue. In the story of the re-establishment of the

Jews in their own land after their exile in Babylon, we read how that Ezra read to great assemblies, day by day, out of a book the language of which now needed to be translated or interpreted to the people. That book is called again and again 'The Book of the law of Moses, the man of God' (comp. Ezra vii. 6 ; Neh. viii. 1, 9, 14 ; x. 29). While yet in exile Ezra was held in high repute, not as a lawgiver, but 'as a *scribe* of the law of the God of Heaven.' His commission from the Persian monarch describes him as 'the priest, the scribe, even a scribe of the words of the commandments of Jehovah, and of His statutes to Israel' (Ezra vii. 11). And he had authority not to form a new constitution for Israel, but to restore the old : 'Thou art sent to inquire concerning Judah and Jerusalem, according to the law of thy God which is in thine hand' (Ezra vii. 14, 21, 26). He was apparently the great-grandson of Seraiah, the chief priest of the beginning of the exile (2 Kings xxv. 18 ; Ezra vii. 1-5). That the law which he had in his hand was the law of Moses which his grandfather or great-grandfather had carried with him to Babylon, can scarcely be called a supposition, it is so obviously natural and inevitable, for on no other supposition could he regard the book of which he was so earnest a student in the days of his exile (vii. 10) as the book of the law whose 'statutes and judgements' the Lord had given by Moses, and which he was now ambitious to teach to his people. Such a man, prepared both by education and by personal zeal

for the great task of the religious restoration of Israel, could not be beguiled either through ignorance or through carelessness, into the adoption, as of Moses, of 'statutes and judgements,' not a century old ; and into the absorption or interpolation of them into the body of the ancient book which contained the statutes and judgements which were really Mosaic. But the honour of Ezra and the honour of the history must not stand in the way of theory. Deceived or deceiver, the book which the great scribe, according to the theory, read to his assembled countrymen, was in no proper sense the book of the commandments of the Lord and of His statutes to Israel *by the hand of Moses*. Here, however, the critic and the history are irreconcilable—the history knowing nothing of a priestly code which received its 'final touches' from the hand of Ezra.

There are critics who take no pains to explain away the conclusion that the critical theory leaves the authors of the historical books of the Old Testament chargeable with dishonesty, and in fact that the books are gangrened with fraud. Kuenen, for example, says that the authors of the books from Genesis to Esther 'fearlessly allowed themselves to be guided in their statements by the wants of the present and the requirements of the future. *They considered themselves exempt from all responsibility,*' and as to the Books of Chronicles, the priests coloured or invented the history to suit their ends without regard to truth.

But 'here (as has been well said) endless difficulties arise to the critics. The books of Moses are so high in moral sentiment, so pure in moral principle, so strong in defence of righteousness, and so full of reverence for truth and God, that it is impossible, morally, to believe that men so falsifying history for a purpose could at the same time have composed such a noble moral structure as the Pentateuch¹.' To which we may add that the history of literature cannot furnish a parallel to the intellectual achievement of the man who could create the Pentateuch out of his own brain, and a few floating national traditions seven or eight centuries after the period and the (supposed) events which it narrates, and give the whole such an air of verisimilitude as to deceive or at least mislead all after ages. The genius, not Isaiah, to whom criticism ascribes the last twenty-seven chapters of the book which bears the name of Isaiah, is not to be compared to him. And yet the moral sense of this great genius was so perverse that he did not hesitate to say times without number, that God spoke words which He did not speak, and ordained laws which He did not ordain!

Non-experts, the unlearned, are in a position to pronounce an unhesitating verdict on the subject of this chapter.

FOURTHLY: The Bible reader does not find in new theories, what he has a right to demand, an intelligent and sufficient substitute for that which they would displace.

The non-experts whose cause I am pleading have reason to distrust and reject the new theory of Hebrew scripture and Hebrew history, because it fails to supply an intelligible and consistent substitute for the old. It is no small matter, looking at it merely from a literary point of view, to pronounce condemnation on that old, which has come to us bearing the seal of a great nation whose self-esteem it never flattered, whose misdeeds it unsparingly condemned, unbroken through more centuries than any other nation, any Western nation at least, has lived. Join in such condemnation, and you are bound to give us a theory of the books and of the history which will recognize acknowledged facts and adequately explain them. On Christian and other grounds we consider ourselves entitled, as we have argued, to reject any theory which involves a charge of historical dishonesty against the Hebrew books. But passing from this, and this aspect of the new criticism, we demand a theory, the fruit, let it be, of the freest manipulation of known materials and the freest use of the critic's imagination, that shall be intelligible and consistent, and that shall supply a credible explanation of the books.

The critics begin with cutting up Genesis and portions of the other books of the Pentateuch, with

the history interspersed, into bits, and these bits they designate with letters which remind one of an algebraic problem. The process began modestly with A, B, C, D. But it grew till we have J. E. Q. P.—with J^1 and J^2 , E^1 and E^2 , P^1 and P^2 and P^3 , D^1 and D^2 , which represent different strata in the hypothetic original documents. Different redactors are embraced under the general symbol R, Rj, who combined J and E, R^d , who added D to J E, and Rh, who completed the Hexateuch (Pentateuch and Joshua) by combining P with J. E. D. The bits, as I call them, thus designated and stamped, written six, eight, and ten centuries after the Exodus, are said to be the primary sources of patriarchal and Mosaic history! If so, the result must have been accomplished by some such mighty and beneficent power as that which transformed the primeval chaos into kosmos. Readers who do not possess the critical ‘second sight’ are more likely to conclude that having kosmos already in the Hebrew books, criticism has toiled to convert it into chaos. We ask with confidence whether the process alleged by the critics, or anything like it, can be made intelligible to any but the critics themselves? And it may be fairly asked whether it is intelligible even to them?

Then as to consistency. The documents, thus discovered and separated, are further discovered to be at variance with each other in their statements respecting numerous particulars, thus invalidating each other’s testimony; and besides they are very

incomplete. Numerous gaps and omissions occur in each. 'But what is more serious,' as Dr. W. H. Green says, 'the parts that yet remain have been manipulated by the various redactors. The order of events has been disturbed, events really distinct have been confused and mistaken for one and the same—while statements which are misleading have been inserted with the view of harmonizing what cannot be reconciled'—and so on, so on.

We look in vain for consistency in this process, or in any result which it could possibly effect. Nor are we aided in the least, rather are we further confounded by the hypotheses which have followed one after another to meet fresh difficulties as they have arisen—and which are known by many names, some of them high-sounding—such as Fragment Hypothesis, Document Hypothesis, Supplement Hypothesis, Crystallization Hypothesis, Modified Document Hypothesis, and Development Hypothesis. There is no subject that gives more scope both for sarcasm and for sound argument than the history of these hypotheses, and the irreconcilable differences which separate critic from critic, and many times the critic from himself at different stages of his mental development. But we forbear.

There is a short and easy method by which imagination can account for the unity and self-consistency, the homogeneity and naturalness, of 'the marvellous' books which we call the 'Pentateuch,' but it does not find favour with English critics. We owe it to what

may be called the French school. Give up all attempt to determine what measure of historic truth, if any, can be found in the books of the Old Testament. These books, with one or two unimportant exceptions, had no existence in the ages to which they relate. They are the product of creative genius, in the age which saw the disappearance of the Persian Empire, 'when the Empire of Alexander moulded the minds of thinking men in a universalist's mould.' To the creative genius of that age we owe all the prophetic and historical books. 'Their narratives have not even an historical residuum, but are simply illustrative religious lessons, which bring in all the patriarchs, Moses, Elijah, and so on. Old names, Egypt and Assyria and Babylon, are used in the prophecies to represent those successors of Alexander the Great who oppressed the Jews.'

One cannot help admiring the simplicity of this theory. Sweeping away the entire old fabric, leaving not one stone upon another, it builds afresh on ground not even cumbered with ruins, and, building at its own sweet pleasure, it can give symmetry and harmony to its new structure. But this theory is too advanced and radical even for the boldest of the theorists with whom we have most to do. They, to use the words of Principal Douglas, reject these teachings as wild fancies. 'I agree with them,' he adds, 'only I do not think these fancies essentially wilder than their own. And Vernes and his friends present a view of the construction of our Old Testament which, apart from

its want of all historical foundation, is much more attractive and perhaps even less burdened with difficulties than theirs.'

The vagaries of criticism can boast both of age and of novelty. Some twenty years ago, or nearly, there appeared a book entitled *Peregrinus Proteus*, by J. M. Cotterill of Edinburgh, in which the author laboured, with no small learning, to prove that not a few ancient works, including Clement's famous Letter to the Corinthians, which have hitherto been regarded as genuine, were forgeries, 'the natural productions' of the age of the revival of letters, an 'age of fraud,' and that the fabricator of the books was in all probability no less a man than the famous French printer, Henry Stephens, known as a Protestant and a fervent denouncer of deceit and superstition, who died in 1520. A contemporary critic of Mr. Cotterill's book said that his method of getting rid of historical evidence reminded him of nothing so much as of Cardinal Manning's famous saying, that we must be delivered from history by the infallible dicta of the Church. It is paralleled now by the 'infallible dicta' of a very fallible Higher Criticism.

FIFTHLY: The faith of the Bible reader in the histories of the Old Testament, and in the account which they give of themselves, is strengthened by the fact that they are confirmed, and that in a very remarkable manner, by modern archaeological discoveries.

There is one department of inquiry which is accessible to all thoughtful students of Holy Scripture, and in which mere scholarship, Hebrew or Classical, gives critics no advantage over those who do not possess it. It is that which is concerned with the results of modern archaeological discoveries in Assyria, Palestine, and Egypt. The most modern living experts in this matter, known to England, are such as Boscawen, Sayce, and Lieut.-Col. Conder, and their testimony confirms and greatly expands the conclusions which defenders of the truth of Bible history had already reached with less knowledge of the facts. It almost looks as if not 'the stars' but a more real power was now fighting conclusively against the assailants of the Bible. Plausible objections to which believers felt that they could offer a sufficient answer, though not an answer that rendered doubt impossible, are now proved, I may say demonstrated, to be utterly groundless. And while these are negated, positive confirmations of Bible history, the patriarchal and later, as striking as they were unexpected, are furnished by recent discovery. Many pages might be filled with illustrations of this averment. But I content myself with a few general statements.

Even with reference to the Book of Genesis Col. Conder does not hesitate to say that the tradition of early times which it has preserved is proved correct by the results of monumental study. 'Viewed in the light of extant monuments,' he says, 'the story of Genesis presents to us a true picture of the state of

Asia before the great Egyptian conquests of the sixteenth century B.C.' Prof. Sayce writes to the same effect: 'The narratives which the Higher Criticism had pronounced to be the unhistorical fragments of popular tradition are being shown by archaeological discovery to be historical after all. Contemporaneous monuments are continually coming to light which prove that in the story of the Patriarchs [in Genesis] and of the Exodus we have truth and not legend Year by year, almost month by month, fresh discoveries are breaking in upon us, each more marvellous than the last, but all as regards the Pentateuch in favour of the Old rather than the New.' 'It may come to be recognized,' says Col. Conder, 'that the words of the Pentateuch form a better foundation for history than the fragments of Manetho, or the baseless theories of those who set aside its dates and its geography as fabrications of a later priesthood.'

Of Joshua he says, 'On no book of the Bible has recent exploration cast more light than on that relating to the story of the Hebrew conquest of Canaan.' Of all recent discoveries, perhaps the most remarkable is that of letters sent to Egypt by the Amorite king of Jerusalem. 'They show,' says Col. Conder, 'that the Abiri [the Hebrews] came from Seir, and fought at Ajalon; that they invaded the Philistine plains, and destroyed all the Canaanite rulers. Their notices agree exactly with the Bible account of Joshua's first campaign. The principal passages in the Jerusalem letters clearly

indicate the path of conquest.' 'The tone of all the Canaanite letters is a despairing cry for help to Egypt; but none of them record that any help was sent, though eagerly expected' (*The Bible and the East*, pp. 103-113).

The most *far-reaching* discovery of recent archaeology is probably that which has swept away for ever an allegation which was long boastfully used as an argument to prove that the writing of the Pentateuch by Moses or by any Israelite in his age was an impossibility. 'It was tacitly assumed that the literary use of writing could not have been known to an Israelite in the time of Moses, and consequently that none of the narratives in the Pentateuch can go back to so early a period. They must all belong, it was urged, to a later age, when little authentic record was preserved of the Mosaic days, and when the imagination of the author or his contemporaries had to supply the missing facts.' There could be, it was alleged, no written contemporaneous evidence of the events of patriarchal times narrated in Genesis, so that the history of any of these events could not be trusted. If, for example, there was no one to record the meeting of Melchizedek and Abram or the conquest of Palestine by the kings of Aram Naharaim, the critic was justified in disputing the historical credibility of these tales. 'Unrecorded events soon pass into forgetfulness or become enveloped in an atmosphere of myth and romance.'

'But now a lost world of culture and civilization

has been brought to light first in Egypt, then in Assyria and Babylonia, and finally in the lands of the Eastern Mediterranean.' 'We can now study the letters of Canaanites who lived before the days of Moses.' The Tell-el-Amarna tablets tell us that in the century before Exodus Palestine was a land of books and schools. All over Canaan there was an active correspondence going on even in a foreign tongue. Such a fact implies an abundance of schools and teachers and pupils. As in Babylon and Assyria, so too in Canaan, there must have been libraries in which the clay books with their wedge-like letters were stored and studied. The historian who desired to compile a history of the cities of Canaan would have had at his disposal more than enough of contemporaneous material. From a period earlier than that of Abraham there were documents containing history of the most authentic and trustworthy kind. The assumption that the Israelites who escaped from Egypt and invaded Canaan were a horde of illiterate barbarians is one which cannot be maintained. To admit that the Israelites were once in Egypt, and yet to deny to them a knowledge at the time they fled from it, is certainly not consonant with the principles of probability and common-sense.

These sentences culled, for the sake of brevity, from Professor Sayce, without the details amid which we find them, justify the general statements which have been already quoted from Sayce and Conder respecting the Book of Genesis. This book, it is

obvious, occupies a different position from that of the other books of the Pentateuch, inasmuch as its contents are pre-Mosaic. It was the first battle-ground of criticism. But all that needs to be said about it here is, that, apart from the witness of Christ to its facts, all improbability arising from the nature and the date of these facts, at least the greater part of these facts, is now more than neutralized. There is internal evidence in the book that it is not a mere compilation of documents or documentary fragments that have come from one knows not how many sources, but that it is written on a distinctly careful plan. Of this there is patent sign in the heading or introduction to ten consecutive sections of the book—‘These are the generations,’ in ii. 4 ; v. 1 ; vi. 9 ; x. 1 ; xi. 10 ; xi. 27 ; xxv. 12 ; xxv. 19 ; xxxvi. 1 ; xxxvii. 2. For the greater part of these there need have been no lack of written materials. But the use of these materials in the preparation of the history does not render the book less a book of Moses, than it would have been if it had contained only speculations woven out of his own brain. And it is not too much to say that the materials were welded together by a wisdom more than that of man, a wisdom which could foresee and contemplate the future.

Well may the believer in Bible history congratulate himself, and expect with confidence the unearthing of more witness to the truth of the old story.

SIXTHLY: The non-expert, instead of being reconciled to the newer criticism, is repelled from it, by the avowal on the part of the critics of faith in the inspiration of the Jewish Scriptures.

The critics do not deny, rather they maintain, they say, the inspiration of Scripture, *but*, 'the current doctrine of Scripture and of Divine inspiration requires revision.' Be it so—and, making no account of such critics as Kuenen and Wellhausen, to whom supernatural revelation is non-existent—what revision, of what amount and of what kind, will bring the doctrine of Divine inspiration into harmony with the facts *as understood by the critics?* We can find no answer to this question in old familiar discussions respecting verbal inspiration and the mode of inspiration. We must even go beyond the question of 'the strict inerrancy of Scripture, of absolute accuracy in unimportant minutiae, or precision in matters of science.' 'The question is whether any dependence can be placed on the historical truth of the Bible; whether our confidence in the facts recorded in the Pentateuch and in other books rests upon any really trustworthy basis; facts, be it observed, not of mere scientific or antiquarian interest, but which mark the course of God's revelations to the Patriarchs and to Moses.' But this is not all. It is a fundamental assumption of critics that the redactors to whom they ascribe the present condition of the books misunderstood or mis-

represented their sources—the more ancient fragments or portions on which they operated; ‘that narratives, which were but varying accounts of the same thing, were supposed by them to relate to distinct occurrences, and they have treated them as such, wrongly assigning them to different occasions and perhaps different persons; that they have combined their sources in such a way as to give a wrong colouring to their contents, so that they make a false impression and convey a meaning quite different from that which properly belonged to them in their original connexion. And the chief value and interest of the critic is thought to be the new light which he brings into the narrative and the altered meaning which he discovers by undoing the work of the redactors, who are supposed to have cut away much precious material from their documents that is now irrecoverably lost, and to have modified the mutilated remnant which they have handed down to us’ (Green, *Higher Criticism of the Pentateuch*, 163, 170).

Now where in all this do we find ‘the place of inspiration’? In the documents or fragments of documents which are supposed to have been the ‘original sources’? On the critical hypothesis, no one knows what they were or whence they came—only this is known, that is, to the critics, that they were confused, mutually contradictory, and liable to all manner of misunderstanding. The redactors cannot have believed such documents to have been inspired, —or if they had, would they have dared to treat them

as they did? Shall we find 'the place' of inspiration in the redactors themselves? Waiving the fact that these editors, who in successive generations have moulded the book into its present form, belong to the race of the great Unknowns of literature, their work is as unreliable, according to the critics, as was the condition of the materials on which they operated. They misunderstood or misrepresented their sources, and, according to the critics to whom alone we owe our knowledge of their existence, they combined their sources in such a way as to give a wrong colouring to their contents.

Were they inspired in doing this? We read of bringing a clean thing out of an unclean, but that were an easy process compared with that which we are asked to accept when we are told that the book, as we have it, is the completed product of documents which even in their first estate were either self-contradictory or unintelligible, and of the toils of editors who misunderstood the documents, and blundered in piecing them together or in framing narratives out of them; and thus written it is inspired! Verily our 'doctrine of inspiration' must be 'revised' in order to meet the exigency to which we are now reduced. We have still to go in search of 'the place' of inspiration, and if it is to be found anywhere it must be in the critics themselves. Their predecessors, the redactors, have erred, and their work is not satisfactory. They, now sitting on the throne of judgement, tell us the whole truth and nothing but the truth. If we deny their

claim to authority or to the inspiration which justifies authority, they can produce a precedent from a most venerable source. In the Council of Trent the question was earnestly discussed whether the Vulgate translation of the Scriptures was inspired. There was reasonable likelihood, it was argued, that the Spirit who had dictated the original had also dictated the translation. Nay, it was ingeniously argued, says Mr. Froude, that the Council then sitting was confessedly inspired. The Council therefore had but to approve the Vulgate, and the Vulgate itself would be inspired !

Very logical ! Quite a precedent for the critics. They have only to assert their own inspiration, and then all else over which they throw the mantle of their authority becomes inspired in virtue of theirs. In this we have the ultimate ' Revision ' of the doctrine of Inspiration !

But the non-expert cannot receive it. It is too hard a saying for both his reason and his conscience. Accepting as he does, and that on grounds which satisfy both reason and conscience, the Old Testament as a record of Divine Revelations given at sundry times and in divers manners, the reverent believer revolts, as I have maintained, from all theories which imply any approach to dishonesty or fraud in the record. With equal vehemence, I might say with equal loathing, he revolts from any theory which would convert the unholy into the holy by putting on it the seal of God, the seal of what apostles held to be the Inspiration of the Holy Ghost (2 Pet. i. 21 ; 2 Tim. iii. 16).

SEVENTHLY: Any argument which may be drawn from the plausibilities of criticism is easily rebutted by the fact that the same sort of criticism, applied to any ancient or even modern book, might be made to yield similar results.

The remark is often made, and made with truth, that the processes by which the Higher Criticism disintegrates the books of the Old Testament, might be applied with equal plausibility to well-known classics of every age, not excepting our own, and produce similar results. This, in fact, has been done. The name of Richard Bentley, whose life ended a century and a half ago, is still held in the highest honour as one of the greatest scholars and critics that England has ever known. His success in disproving the authenticity of a series of letters which were ascribed to Phalaris, the semi-mythical tyrant of Sicily, seemed to invest him with a critical dictatorship. Queen Caroline is said to have expressed a wish that the great critic should exercise his talents upon an edition of Milton, and thus gratify those readers who could not enjoy his celebrated lucubrations on classical writers. 'Probably she thought (says Professor Jebb) that the learning, especially the classical learning, which enters so largely into Milton's epic would afford a good field for illustrative commentary to a classical scholar.' But the critic found what no one had hitherto suspected, that there were many words in

the poem which Milton had never dictated, and not a few passages which were in no sense his. And of this strange phenomenon Bentley had a ready explanation to offer. The author was obnoxious to the government, poor, friendless, and, worst of all, blind, and 'could only dictate his verses to be writ by another.' The amanuensis made numerous mistakes in spelling and printing, which Bentley found no difficulty in correcting. But the *Editor* was the chief offender. 'The friend to whom Milton committed his copy, and the overseeing of the press, did so vilely execute the trust, that *Paradise* under his ignorance and audaciousness may be said to be *twice lost*.' This *Editor* is responsible for many careless changes of word or phrase, of which Bentley gives forty-eight examples. But that is not the worst. This Editor, knowing Milton's bad circumstances—the evil days and evil tongues—profited by them to perpetrate a deliberate fraud of the most heartless kind. Having a turn for verse-writing, he actually interpolated many lines of his own, of which Bentley's insight discovered 'sixty-six examples, which can be detected by their own silliness and unfitness.' Besides, Milton himself 'made some slips and inadvertencies.' 'There are some inconsistencies in the system and plan of his poem, for want of his revisal of the whole before its publication.' Sixteen examples of these are given. These are beyond merely verbal emendation, and require 'a change both of words and sense.'

It is quite unnecessary to criticize this criticism

of the great critic. The *Editor* who was guilty of so much wrong owes his existence, as Professor Jebb remarks, to Bentley's vigorous imagination. And if any one should be curious to see what reply may be made to the hypothetic charges of 'wilful interpolations and inadvertent changes,' he will find it in the professor's recent life of Bentley. Enough for my purpose to exhibit Bentley's edition of *The Paradise Lost* as a prophetic precursor of the editions of *The Law of Moses*, *the Book of the Prophet Isaiah*, and other portions of the Old Testament which are offered to us by the Higher Critics; only that the foreshadowing was faint and timid. For whereas the critic of *Paradise Lost* imagined only one Editor, the critics of the Old Testament *imagine* many—a fresh one whenever occasion renders it necessary—to whom, under an appellation unknown to Old Testament history, that of Redactor (? Reviser and Reconstructor), is ascribed everything which the critic *thinks* cannot have been original¹.

In maintaining that the ancient belief in the Mosaic authorship of the Pentateuch is worthy of all accept-

ation, and that the denial of it involves the destruction of confidence not merely in the inspiration of what we are accustomed to call Holy Scripture, but in its historic truthfulness, and in the veracity of its writers, we do not forget that an attempt is sometimes made to throw doubt on such conclusions by the off-hand averment that we have not the books of Moses as they came from the hands of Moses ; if indeed they were really his. This is a statement which is altogether misleading. We have these books substantially in the only form in which we have any evidence that they ever existed. To the remarks bearing on this point, which will be found in pp. 30-36, may be added an appeal to the Samaritan Pentateuch as a convincing witness to the integrity of 'The Law' as it came from the hands of Moses. The Samaritans, whose national origin dates from the division of the kingdom on the death of Solomon, declined to accept the later books, which they identified with the rival kingdom of Judah. Had the books which are ascribed to Moses originated in the later age which the Higher Criticism imagines, they could not have become the Bible of the Samaritans.

There are one or two expressions and one or two verses which, it is affirmed, cannot have been written by Moses. Of these the words in Gen. xxxvi. 31 are specially insisted on : 'These are the kings that reigned in the land of Edom, before there reigned any king over the children of Israel.' These words, it is said, could not have been written till kingship was established in Israel. But Delitzsch holds that the narrator might

have inserted this clause from the standpoint of the promise to Abraham in Gen. xvii. 6, and to Jacob in Gen. xxxv. 11. And Dr. W. H. Green, recalling the fact that Edom had been a nation with dukes and kings for four hundred years, while Israel had been bondsmen and kingless all these centuries, it was only natural to mark the contrast, and after thorough discussion, concludes that 'instead of indicating an anachronism, the form of expression points directly to Moses as its author' (*The Unity of the Book of Genesis*, pp. 425-429).

But even if this and a few other similar passages can be found which really point to a later age than that of Moses, it is not unreasonable to suppose that they were inserted by prophetic authority to make the story more intelligible to later readers. Whereas if we ascribe the books themselves, as they now stand, to a later age we have to face all the difficulties—logical, historical, moral, and religious—which have been expounded within the too narrow limits of this Primer.

There is one chapter in the Book of Deuteronomy which it is certain that Moses did not write, that which contains the history of his death. But the criticism which, because Moses did not write the account of his own death found in a book which bears his name, throws doubt on whether he did write, and suggests that he could not have written, the history of events and discourses found in the chapters which precede his death, scarcely deserves the trouble of refutation. It is almost like saying that because the dead man

could not tell us how he died, the living man could not have told us how he lived, or what he did while he lived.

Instead of finding in the last chapter of Deuteronomy any occasion of doubtfulness as to the Mosaic authorship of the Pentateuch, we find in it strongly corroborative evidence of the truth of the recorded history of which it is the conclusion. For

(1) Why should the book—fivefold, as we have it, but really one—be wound up with a detailed account of the death, and that in very peculiar circumstances, of the man Moses? The only answer that is at all rational is—because of the extraordinary position which this man had occupied, and the extraordinary work which had been assigned to him, and whose faithfulness in accomplishing it, as ‘the servant of God,’ the New Testament does not shrink from comparing with the faithfulness of Christ as ‘the Son of God’ (Heb. iii. 2; Numb. xii. 7).

And (2) why such a death? at once painful and blessed—in one respect punitive, in another the reward of faithful service? The preceding history, as we find it in Numbers xx. 12 and xxvii. 12–14, explains its double character. To Moses it must have been a privation of bitter severity to be deprived of the privilege of leading the redeemed host into the promised land, but at the same time it must have been a great joy to see the land, and then to rest from his labours in the peace of God.

Thus this last chapter of the Pentateuch would be unintelligible without the history which certain critics

would stamp as untrustworthy, and that history would be incomplete without this record of the life's-end of the great leader and lawgiver, whose voice we hear and whose steps we follow through its pages. Who wrote this supplemental note we do not know. But how its incidents became known we can understand. As Elisha was permitted to accompany Elijah, and to talk with him, up to the moment when the chariot of fire separated them, so Joshua—why should we doubt it?—who had been honoured to attend on Moses as his minister on Horeb (Exod. xxiv. 13), was privileged to accompany Moses and hold converse with him until the Lord was pleased to separate them—it may be by a cloud—Moses to die, and Joshua to descend to his work as the Captain of Israel.

The verses which follow the account of the death of Moses, the last in the book, must have been written long after, probably centuries after, the events recorded in the book, but instead of suggesting doubt respecting the contents of the book, they confirm them. Why should we be told that 'no prophet like unto Moses whom the Lord knew face to face' had yet appeared in Israel? Because Moses was the Prophet of the book, and himself had foretold, as written in the book (ch. xviii.), that a prophet like unto him, endowed as he was, and divinely privileged as he was, should at some future time appear in Israel. The words with which the book closes put the seal of a later age on the prophecy and the book which contains it.

CONCLUSION

THERE are not a few questions which will occur to non-experts who read these pages, but I can do little more than refer to them. For example, How are we to regard the Bible as a whole in the light of the asserted results of the Higher Criticism? If these results in regard, say, to the Pentateuch and Joshua, to say nothing of Daniel and many separate passages and chapters in other histories and prophets, are genuine, and give us the truth respecting these Scriptures and portions of Scriptures, what effect will this have on our estimate of the Bible as a whole? I see no logical or common-sense answer to this question, but that the Bible must lose all credit for historical truthfulness or trustworthiness. I can understand the distinction which is insisted on when it is said that the Bible is not the Word of God, it is only the record of the Word—a distinction which is more apparent than real, for if it be a record of Divine revelations, such as is to be found in no other book or collection of books, neither in nature, which we are sometimes reminded is a word of God,

nor in Providence, which may claim the same honour, —if it occupies so unique a position in the relations between God and man, we cannot be far wrong in calling it ‘the Word of God.’ It would be difficult to dissuade the devout heart from using an appellation which is not only convenient for its brevity, but which puts emphasis on, and brings into prominence, the very essence of the book.

But if it be a record of Divine revelations, we must repudiate every theory and every shade of criticism which would stamp any part as untruthful and untrustworthy. It is the voice of God Himself that comes to us through Jeremiah, ‘cursed be he that doeth the work of the Lord deceitfully.’ And further, we need have no hesitation in applying to the critical theory which we are discussing the words of Dean Milman in regard to the once popular Tubingen theory of the New Testament: ‘It seems to me that instead of the theory being the result of diligent and acute investigation, the theory is first made, and then the inferences or arguments sought out, discerned, or imagined, and wrought up with infinite skill to establish the foregone conclusion; at the same time with a contemptuous disregard or utter obtuseness to the difficulties of their own system.’

At the same time out of evil God educeth good. Whatever may be the immediate or ultimate effect of the speculations of the Higher Criticism, we sympathize entirely with the conclusion of Dr. William Henry Green. ‘While the hypothesis, i. e. of partition,

has proved futile as an attempt to account for the origin of the Pentateuch, the labour spent upon it has not been entirely thrown away, and it has not been without positive advantage to the cause of truth. (1) It has demonstrated the impossibility of such a partition. The experiment has been tried in every way that the utmost ingenuity could devise, but without success. (2) It has led to the development of a vast mass of positive evidence of unity, which would not otherwise have been so diligently sought for, and might not have been brought to light. (3) It has led to the elucidation and better understanding of the Pentateuch, from the necessity thus imposed of minute and thorough investigation of the meaning and bearings of every word and sentence, and of the mutual relations of every part. It verifies the old fable of a field which was dug over for a chimerical purpose, but the labour thus expended was rewarded, for an unlooked-for harvest sprung from seed which lay unsuspected in the soil' (*On the Higher Criticism of the Pentateuch*, p. 132).

I venture to add the words of warning in which Dr. Green concludes the volume from which I have just quoted. 'Within a very few years professedly evangelical men have ventured upon the hazardous experiment of attempting a compromise in this matter. They propose to accept these hypotheses in spite of their antibiblical character, in spite of their incompatibility with the historical truth of the Bible, in spite of their contravening its explicit statements,

in spite of the grave questions which they raise respecting the fallibility of our Lord's own teaching ; and they expect to retain their Christian faith with only such modifications as these newly adopted hypotheses may require. They are now puzzling themselves over the problem of harmonizing Christ's sanction given to false views respecting the Old Testament with implicit faith in Him as a Divine Teacher. And some of them in their perplexity over this enigma come perilously near impairing the truth of His claims. Would it not be wiser for them to revise their own ill-judged alliance with the enemies of evangelical truth, and inquire whether Christ's view of the Old Testament may not, after all, be the true view ?'

In drawing this argument to a close the reader's attention is directed to the motto which appears on the title-page—'In understanding be men.' The reader needs no help towards distinguishing between those attributes of childhood without which we cannot enter the Kingdom of Heaven, and those characteristics of which we are reminded by the words, 'that we henceforth be no more children tossed to and fro and carried about with every wind of doctrine.' 'Prove all things,' writes one apostle ; 'hold fast that which is good' (1 Thess. v. 21). 'Believe not every spirit,' says another, 'but try the spirits whether they are of God : because many false prophets are gone out into the world' (1 John iv. 1). It is the author's hope that this little book will be subjected in all its reasonings

to the 'proving' and 'trying' which are thus enjoined by apostolic authority. It seeks no shelter for them other than is found in their own validity and truth. 'In understanding be men.'

Children are subject to what may be called a centripetal and a centrifugal force. On the one hand they are exposed to the danger of being drawn too strongly, and of adhering too tenaciously to what they have been taught, and what has become sacred through early associations. And on the other hand they are in danger of being drawn away too readily, startled or frightened away, from what they have been taught by bold and specious novelties, and the confidence, often the supercilious confidence, of men who claim to have discovered what has been hid from the ages that have gone before. We have, as not children but men, on the one hand to guard against a blind and obstinate maintenance of inherited opinions in the face of reasons that should suffice to quench them; and equally to guard against pretentious theories, whose chief power or fascination is in their 'newness.' It cannot be too strongly insisted upon, that while in science, and in many of the practical applications of science, we have to place ourselves in the hands of experts or specialists, the materials for forming a judgement on the most prominent religious problems of the day are within the reach of ordinary intelligence, and ordinary intelligence has to guard against too facile yielding to either centripetal or centrifugal forces.

Men are sometimes applauded for their courage in

breaking loose from old moorings, and advancing, as the phrase is, with the times. But it often requires more courage and more strength to hold fast by the old moorings than to break away from them. The times often advance the wrong way, and have to retrace their steps in search of light and truth. There is nothing more humiliating in the history of human thought than the record which it contains of bold conclusions, adopted in the very name of science, surrounded for a time with a glamour which makes it almost impious to question them, and then repudiated, cast away as vain idols—only, however, to give place to equally vain idols that may be worshipped for another season. Dean Farrar, speaking of the critics which have from time to time assailed the authenticity of the Gospels, says, ‘The schemes which have been proposed by rival critics with so much arrogant confidence and mutual contempt, have succeeded to each other in such bewildering multitudes, like waves rushing over waves, that we know not whether most to be astonished at their rapidity or to despise their evanescence¹.’ The remark is equally true of ‘the schemes which have been proposed by critics’ for revolutionizing our conceptions of the Old Testament, and reducing the avowed history of the ancient Church of God, very greatly into a mass of legends and myths, and, at the best, of well-intentioned endeavours of unknown men to do good by means which it would require a Jesuit’s subtlety to distinguish from forgery. Of these

‘schemes,’ another dean, writing in very mild terms, says in answer to the question, ‘What does criticism say?’ ‘Here it seems to me that while the questions have been innumerable, and the answers also, the crop of clear, certain, and convincing answers, has been a singularly small one. Nothing seems to me more remarkable than the contrast in our time between the certainties of physical science, and the contradictory and uncertain results, the barrenness, as a whole, of criticism applied to the questions which most interest men¹.’

Had Dean Farrar carried to the study of the Book of Daniel the principles which he maintained so eloquently in his Hulsean Lectures in defence of the Gospels, he would not have accepted the conclusions of the extremest Rationalism, conclusions which, if true, should drive the book ignominiously out of the canon of Holy Scripture. He would have found no difficulty in proving—and this has often been done—that the Daniel of the Book was what Christ called him, a ‘Prophet,’ and one who was honoured to supply Christ Himself with words in which to describe the glory of His second coming (Matt. xxvi. 64).

The late learned Dr. Cairns, writing to his friend Dr. John Brown, said, ‘The dulness of criticism [of the Rationalist school] is seen in the non-appreciation of the grandeur of Daniel, which every fool of the Maccabean age is supposed capable of having written, or according to some, a joint-stock company or for-

tuitous concourse of fools and fanatics, whose fabrications run into such sublime shapes as Belshazzar's vision, and Daniel's prayer, not to speak of Nebuchadnezzar's dream. Surely the time will come in all lands when some sort of elementary feeling for the sacred and the great will be so diffused as to nip such absurdities in the bud, and serve as a foundation for the positive Scripture criticism and exposition to build upon ¹.'

The unlearned non-experts, whose rights and powers we here plead, need have no fear for the future of their Bible. They need no aid from superstition or ignorance to defend the Book, nor need they shut their eyes against any light that may come from true criticism, from historical discovery, from linguistic progress, or from profounder insight into the truths of revelation. Its destined course among the nations is that of the 'Light, which shineth more and more unto the perfect day.'
